Pursuant to P.A. 207 of 2018

Article V, Section 802

Physical and Mental Health Care Expenditure Report – FY19 1st Quarter

Sec. 802. As a condition of expenditure of the funds appropriated in part 1, the department shall provide the senate and house appropriations subcommittees on corrections, the senate and house fiscal agencies, the legislative corrections ombudsman, and the state budget office with quarterly reports on physical and mental health care detailing quarterly and fiscal year-to-date expenditures itemized by vendor, allocations, status of payments from contractors to vendors, and projected year-end expenditures from accounts for prisoner health care, mental health care, pharmaceutical services, and durable medical equipment. These reports shall include a breakdown of all payments to the integrated care provider itemized by physical health care, mental health care, and pharmacy expenditures.

Status of Payment from Contractors to Vendors - The Michigan Department of Corrections (MDOC), Budget and Operations Administration, conducts a monthly financial review of Corizon payments for timeliness and accuracy of claims payment information. The financial review for payment status of claims for Service dates beginning 11/1/2017-11/30/2018 for the contract with Corizon showed that 84.9% of received claims were paid within 45 days. Of the 53,079 service claims received and processed from 11/1/2017-11/30/2018, there were 45,056 vendor claims (complete and with authorization codes) paid within 45 days. There were 8,023 vendor claims (15.1% of the total vendor claims) paid after 45 days. Monthly reports are received by the MDOC detailing the status of all claims. There were no complaints to the MDOC during this quarter from vendors receiving late payments from Corizon, for their services.
