
Huron County Caseville Township T.17 and 18N R.10E



# Department of Natural Resources Division of Land Resource Programs High Risk Erosion Boundary and Breakpoint Descriptions Caseville Township, Huron County

The west end of the high risk erosion area in Section 7, T17N, R10E, is located 760 feet east of the intersection of the Section 12-7 line and the shoreline.

The east end of the high risk erosion area is located 2,205 feet east of the intersection of the Section 12-7 line and the shoreline.

The west end of the high risk erosion area in Section 5, T17N, R10E, is located 1,005 feet west of the intersection of the Section 4-5 line and the shoreline.

The east end of the high risk erosion area in Section 4, is located 2,030 feet east of the intersection of the Section 4-5 line and the shoreline.
