

Explore MI Wetland Wonders Contest Terms and Conditions

- A participating individual must agree to the terms and conditions that are listed below by the Michigan United Conservation Clubs and Michigan Department of Natural Resources.
- The Explore MI Wetland Wonders contest will begin on May 5, 2021 and continue through July 16, 2021.
- To be entered into the prize drawing, an individual must have visited one of Michigan's Wetland Wonders and have taken their photo by an official Game or Wildlife Area sign at the location. Photos should be submitted to DNR-WetlandWonders@Michigan.gov with the contest entrant's name, email address, and phone number.
- The 15 official Wetland Wonders Sites are: Sturgeon River Sloughs SWMA (Houghton and Baraga counties), [Portage Marsh SWMA](#) (Delta County), [Munuscong SWMA](#) (Chippewa County), [Manistee Marsh at Manistee River SGA](#) (Manistee County), [Houghton Lake Flats SWMA](#) (Roscommon County), [Wigwam Bay SWA](#) (Arenac County), [Nayanquing Point SWA](#) (Bay County), [Fish Point State Wildlife Area](#) (SWA) (Tuscola County), [Crow Island SGA](#) (Saginaw County), [Shiawassee River SGA](#) (Saginaw County), [Fennville Farm Unit](#) at the [Allegan SGA](#) (Allegan County), [Maple River SGA](#) (Gratiot and Clinton Counties), the [Muskegon County Wastewater Facility](#) (Muskegon County), [St. Clair Flats SWA on Harsens Island](#) (St. Clair County) and [Pointe Mouillee SGA](#) (Monroe and Wayne counties).
- Upon submission of an official email contest entry form, an entry receipt will be provided via e-mail.
- An individual may receive additional contest entries by visiting more than one Wetland Wonder site during the same contest period. Each additional visit results in an additional contest entry.
- Four winners will be randomly selected on July 23, 2021. Selection of the four winners will be by order of random selection. Winners will be notified by phone or email and given instructions to collect their prizes. Prizes must be collected within 60 days of selection or forfeiture will occur.
- Winners may only win the Explore MI Wetland Wonders prize package once. If a winner is selected that has already won the Explore MI Wetland Wonders contest, an alternate winner will be chosen by random selection.
- There may be additional terms and conditions on individual prize items. Please refer to individual prize items for details.
- In the event that a minor wins a prize package, a legal parent or guardian will be given possession of the prize.
- MUCC and Michigan DNR employees are ineligible to participate in the Explore MI Wetland Wonders contest.
- MUCC and the Michigan DNR hold the right to alter and modify the terms and conditions of the Explore MI Wetland Wonders contest throughout the term of the contest.
