# Scrap Tire Advisory Committee Meeting 06/18/2019 Minutes

#### **Guest Speaker:**

- Matt Lamb, Porous Pave
  - Two products:
    - XL which is 50% rubber / 50% aggregate
    - XLS is 100% rubber, 300 tires per 1,000 square feet
    - 27% void space
    - Can be installed in temperatures down to 45 degrees
    - Also manufacturing Sand Guard bunker liners for golf courses
  - Have currently used 13 million pounds of tires (11 million pounds from Michigan)
  - Can use material over existing surface
  - Minnesota has converted over 70% of tennis courts into pickle ball courts
  - Grand Rapids tree surround project
    - Easier maintenance (hypodermic needles are frequent in tree grates, cause hazmat response and additional expense)
    - Lowers trip hazard and potential lawsuits
    - Sloughs off as trees grow
  - Non-skid properties, ADA compliant
  - o Flexible resists cracking/heaving 50% rubber allows the product to move
  - o Can be applied down to 45 degrees and cures in 24 hours
  - Paths/Trail applications
    - Dow Gardens (Midland)
    - MSU walkways
    - Arlington National
  - Leaching Question (John Sherrin) leaching test report is available
  - Golf application
    - Cart paths Bell Mead (TN) and Augusta National (GA)
    - Sand Guard product XLB
  - o Playground surfaces fall rating (4-9 feet) with safety pad and porous pave XLS
  - Pool surrounds
  - Typically, more expensive than asphalt (upfront costs) need to consider true Life Cycle Analysis costs
  - o Comment: need to look for a joint project that highlights porous pave, tire mulch, other sustainable materials in landscaping (i.e. Clare Welcome Center)
  - Municipal interest anti-skateboarding issues (not an ideal surface)
  - Porous pave versus concrete cost comparison needed (with Life Cycle Analysis)

## **Topics:**

- Michelin and GM Announce Airless Tires for Passenger Vehicles
  - How to handle recycling rubber treads with carbon fiber rims
  - Bridgestone also has prototype
  - Similar issues with self-sealing tires (i.e. Tiger Paw)
  - Goodyear self-sealing tire has yellow sticky substance that jams up processing equipment per Deerpath; concerns about no communication between tire manufacturers and processors
- End Use Report for Calendar Year 2018
- TDF:
  - o 7 biomass plants in operation
  - 3 contracts ended/status
    - New contracts for Viking Lincoln and McBain for 8 year terms with 20% rate cut (tied to natural gas market pricing)
    - Hillman contract is signed pending PSC approval with approximate 25% reduction in fuel consumption
    - Filer City contract is 2025
  - Continuing to work on keeping the plants viable, very important to their local economies and northern Michigan
- Enforcement cases:
  - Successful bond call for hauler bond (\$10,000) improper disposal of scrap tires project to put fire lanes/mosquito control will be put out to bid
  - Several other bond call-ins are in progress

### **Grant Updates:**

- 2019 Clean-up
  - o 65 applications funded for \$983,244
  - Working through system changes that have affected timely payments and reimbursements
- Lake Superior tire cleanup working with the grantee (Lake Superior Watershed Group)

- o EGLE Drone footage from Ontonagon
- Superior Watershed Partnership is grantee, they have student interns assisting
- Working on permitting issues and access agreements
- 2018 Clean-up:
  - 3 did not utilize grant funding
  - 82 grantees = \$865,000 (490,000 PTE) numbers will increase with pending closeout numbers from the City of Detroit
  - \$865.092.39 spent to date (one grant was extended until 05/31/19)
  - 489,039 passenger tire equivalents to date
- Market Development
  - Scrap tire paving research project for transportation committee
  - o 31 eligible applications received requesting in excess of \$8 million in 2019
  - o 2019 Market Development grants
    - Entech
    - Cobalt
    - City of Mackinac Island
    - Marguette County Solid Waste Management Authority
    - Kent County Road Commission
  - o Scrap Tire Market Development study RFP applications have been reviewed
- Dickinson County Road Commission project (2018 MD Grant)
  - o Good press coverage both during active project and at ribbon cutting ceremony
  - Partnership with Michigan Technological University
  - 3 test phases
  - Project partners/contractors Asphalt Plus/Bacco
  - Dry process first time in MI
- Midland County Road Commission project (2017 MD Grant)
  - TDA for stormwater control including testing
  - RMA in road surface
- Law Enforcement grant with City of Detroit Police Department has been executed
  - o Two police officers assigned and will be also working with local community officers
  - Hoping for prosecutions
  - o Stepping up local enforcement in partnership with District scrap tire staff
  - o Grant kick-off meeting is June 26, 2019
