Pursuant to MCL 339.2405(2)&(3), the Bureau of Construction Codes (BCC)¹ has **suspended** the following licenses:

- Snyder's Roofing LLC, Eric David Snyder, Qualifying Officer, Company Residential Builder License No. 21-02-202130 (expiration 5/31/2020), and
- Eric David Snyder d/b/a Snyder Roofing, Individual Maintenance and Alteration Contractor License No. 21-03-101467 (Lapsed 5/31/2011)

¹ Effective August 27, 2018, the licensing and regulation of the Residential Builders and Maintenance and Alteration Contractors occupation was transferred to the LARA Bureau of Construction Codes (BCC), from the LARA Bureau of Professional Licensing (BPL).

The licenses have been suspended because the Individual Residential Builder License of Eric David Snyder, No. 21-01-199116, was suspended for failure to comply with the conditions of two (2) Consent Orders (listed above), including:

Complaint Nos. 324753 & 324752

- Payment of \$500.00 fine, due within 60 days of the effective date.
- Failure to comply with terms of the Order shall result in a suspension of all licenses held by Respondent under Article 24 of the Occupational Code.

Complaint Nos. 324753 & 324752

- Payment of \$1,000.00 fine, due within 60 days of the effective date.
- Proof of restitution payment of \$1,044.60 to the City of Grand Rapids, due within 60 days of the effective date.
- Failure to comply with terms of the Order shall result in a suspension of all licenses held by Respondent under Article 24 of the Occupational Code.

The fine payments and the proof of restitution payment required by the Consent Orders must be submitted to the Department at the following address: Department of Regulatory Affairs (LARA), Bureau of Construction Codes (BCC), Licensing and Compliance Division, Compliance Section, P.O. Box 30254, Lansing, MI 48909. The check or money order must be made payable to the State of Michigan and clearly print the above complaint numbers on it.

You are hereby notified that any residential building activity requiring a license conducted on or after the date of notice of suspension (March 25, 2019) is unlicensed activity, in violation of the Michigan Occupational Code and subject to administrative and/or criminal penalties; see MCL 339.601(6)(a)-(c) for criminal penalties, in addition to administrative penalties, see MCL 339.601(12) and 602 (*excerpt attached*).
