Re: Wireless Vision, 40700 Woodward Avenue, Suite 250, Bloomfield Hills, MI 48304.

We write to provide notice regarding layoffs at Wireless Vision. Due to the unforeseeable business impacts of the COVID-19 pandemic and associated closure orders, together with the recent merger between Sprint and T-Mobile, Wireless Vision had to make the decision to lay off thirty-seven (37) employees located at or based from its headquarters at 40700 Woodward Avenue, Suite 250, Bloomfield Hills, MI 48304.

The layoffs began on April 30, 2020 and we previously provided each affected employee with notice of his/her layoff. The current layoff numbers at this location are below Worker Adjustment and Retraining Notification (WARN) Act notice criteria. We do not currently anticipate a need for layoffs that meet WARN criteria, however because we do not know what the future may hold with respect to any ongoing COVID-19 impacts, reopening plans, and economic recovery across our US operations, we are providing you with this notice now. The following additional information is available to you upon request: the dates of separations, the job titles of positions affected, and the number of affected employees in each job classification. The affected employees are not represented by a union and there are no bumping rights. The above information is maintained at company headquarters at 40700 Woodward Avenue, Suite 250, Bloomfield Hills, MI 48304.

Whether or not these actions presently trigger the requirements of WARN, we thought it appropriate to give you this notice. We are taking these employment actions because of COVID-19 and concurrent related business circumstances that were not reasonably foreseeable. We are providing this notice as soon as practicable. To the extent that these or any future layoff decisions constitute a covered event under the WARN Act, this letter is intended to fulfill any requirements of WARN.
