#### WHO MUST TAKE THE ASSESSMENTS

Technical skills assessments are given to **all** students who have completed a career and technical education (CTE) program in the current year **OR** are leaving a program/school and have completed more than half of the program (at least seven segments).

### **General Updates**

#### **PERKINS V - REMINDER**

Technical skills assessments <u>will be</u> required during the 2018-2019 academic year only, and all required assessment implementation procedures/processes will be in place for 2018-2019. However, as Technical Skills Attainment is not a Core Performance Indicator under Perkins V, <u>beginning with the 2019-2020 school year</u>, districts will no longer be required to administer or report Technical Skills Assessments by student. Programs are encouraged to continue to offer students opportunities to earn industry-recognized credentials of value to employers or for postsecondary credit purposes, and districts will continue to be asked to indicate the industry credentials available to students by PSN.
