Assessment Name: National Health Science Assessment

Assessment Description:

The National Health Science Assessment and Certificate Program (NHSA) is a certificate program offered by the National Consortium for Health Science Education (NCHSE), and it measures student mastery of basic skills and knowledge that workers in all aspects of the health industry need to know. The assessment satisfies the technical skills assessment requirement in state and federal legislation.

Content Areas Covered by the Assessment:

The NHSA is based on the National Healthcare Foundation Standards and Accountability Criteria. The foundation standards covered are as follows: academic foundation, communications, systems, employability skills, legal responsibilities, ethics, safety practices, teamwork, health maintenance practices, technical skills, and information technology applications. The assessment program includes the following components: portfolio (optional), pre-test (optional), and the post-test.

How many questions are on the assessment and is the assessment timed?

The assessments are delivered online and provide immediate results feedback. Both the pre- and post-test consist of 100 multiple-choice test items that align directly to the National Healthcare Foundation Standards. The pre-test is not a requirement for state reporting. There is a 90 minute time limit. However, time can be extended, if needed, by contacting Precision Exams. Students must complete the assessment in one sitting. It is not a save as you go assessment. Who must take the assessment?

Students enrolled in the state-approved CTE programs listed above whom either:

1) Completed the program in the current school year (have completed all 12 segments) with a 2.0 or better in each course section.

OR-

 Are program concentrators (completed more than half the program – seven or more segments) and who will leave school at the end of the current school year.

What is the procedure to order assessments?

Go to <u>Precision Exams</u> at http://www.precisionexams.com/nchse.

Step 1: Purchase exams with a purchase order or credit card. Tests are not refunded, so please ensure that the correct number of tests are ordered. Tests can be used for 18 months. The school name will then be entered into the system.

Note: If there are multiple schools under a RESA/ISD purchase order, then all schools must be listed on the purchase order so that Precision Exams can enter all the school names and not just the ISD/RESA. If this step is not completed, then the proctor at the local school will have not have a school to select in the system when registering.

Step 2: Register as a proctor. See the following link. A unique ID number is required for registration. This number can be an employee ID or some other unique ID. Please see the following link to the Proctor Registration Guide for step-by-step procedures:

After registration is completed, within 12-48 hours, an email will be sent to the proctor with a login ID and password to create test codes and complete test setup.

How much does the assessment cost?

\$15.00 per assessment (online administration) due to consortium membership.

How is the assessment administered?

The assessment is administered online by <u>Precision Exams</u> at http://www.precisionexams.com/nchse

How much time do students have to take each test?

The students will have an unlimited amount of time to complete the test. The exam will start with a 90 minute time limit. However, time can be extended, if needed, by contacting Precision Exams. Students must complete the assessment in one sitting. The student cannot log off and log back on to finish the assessment. The average student takes about 90 minutes to complete the assessment.

Use of tools to take test?

No dictionaries. Calculators may be used so long as they are **provided by the proctor**. Students are **NOT** to use their own calculators or cell phones.

There is a 25 question sample practice exam that proctors can deliver to students for no charge. There is also a 100 question pre-test available online that is the same cost at the post-test. The pre-test is not a requirement for state reporting.

Precision Exams uses a different form for the pretest. **Pretesting is allowed**. Please visit the Precision Exams website for additional information on pretesting.

What is the testing window?

Please abide by students' individual education plans for accommodations. Accommodations can be provided such as extended time, exam reader, and questions can be read to more than one student by "turning off" randomization. To request accommodations, contact Precision Exams at least 24 hours before the assessment is administered. Provide the students' name and UIC number.

Non-English Languages Available:

The assessment is not available in other languages.

How are reports accessed?

Proctors may download reports within 15 minutes after the assessment is administered. Precision Exams' report server is on a 15 minute batch cycle, so it may take up to 15 minutes for the proctor and/or administrators to actually print the reports.

What is a passing score on the assessment?

The NHSA cut score is 70%.

Who should teachers contact with questions about instruction?
