Access to SAT and PSAT Test Cycles on the Secure Site

The Division of Accountability Services (DAS) has been receiving many calls and emails from users of the Secure Site in regards to not having access to the SAT, PSAT 9 and PSAT 10 test cycles in the Secure Site. The SAT, PSAT 9 and PSAT 10 are new assessments for Spring 2016 and **only district administrator level users** of the Secure Site have access to SAT, PSAT 9, and PSAT 10 on the Secure Site. The district administrator level users of the Secure Site will need to give access to SAT, PSAT 9 and PSAT 10 to appropriate users in their districts. If you should have access to SAT, PSAT 9, and PSAT 10 and do not, you should contact your district administrator level user of the Secure Site, who is usually, but not always, the district assessment coordinator for assistance. MSDS Data Pull for Limited English Proficient (LEP) Students in Grades K–12 for WIDA

The Division of Accountability Services (DAS) will do a final pull of student enrollment and demographics for WIDA assessment and accountability reporting from the Michigan Student Data System (MSDS) using the data submitted and certified by 5:00 PM on May 2, 2016. We will pull the Fall MSDS General Collection (fall count day), Spring MSDS

General collection (spring count day), and student record maintenance (SRM) files submitted through May 2, 2016 at 5:00 PM, with an “as of date” on or before March 25, 2016. Student exit and enrollment information along with student demographics will be pulled from MSDS. It is especially important to make sure students who take the WIDA are identified as LEP in MSDS by May 2, 2016 with an **“as of date” on or before March 25, 2016** or the WIDA test will be invalidated and the student will not receive WIDA scores.

The Secure Site is currently updating student demographics (not enrollment or exits) from MSDS daily. If you pre-identify a student to the WIDA, and LEP is not updated and marked on the Secure Site by the following day, check with your district MSDS person to make sure the student will be included in the Spring MSDS General Collection as LEP.

Revised Draft ELA Essential Elements Documents for MI-Access Now Available for ALL Grade Levels

Pre-ID Window Now Open in the Secure Site

Pre-ID is a process by which schools identify 9th, 10th, and 11th grade students who are participating in statewide assessments in the Secure Site. This step is necessary in order for College Board to ship the necessary test materials and labels to schools for test day. The Pre-ID process must be completed by **February 16, 2016** in order to receive barcode labels and materials; after that date students must still be pre-identified in the Secure Site, but schools will be responsible to print barcode labels from the Secure Site. PSAT 8/9, PSAT 10, and SAT Accommodations Requests – Submit by February 16, 2016

All schools should have begun the process of requesting accommodations for these tests. Remember, if a student has been approved for a College Board Accommodation previously—for example if they tested PSAT/NMSQT in Fall 2015 or AP testing in a prior year—the accommodations request does not need to be resubmitted unless there has been a change.

Requests should be submitted for all students requiring accommodations for PSAT 8/9 (9th grade), PSAT 10 (10th grade), and SAT with Essay (11th grade). The state-sponsored administration requires ALL accommodations requests to be submitted through [SSD Online](https://www.collegeboard.org/students-with-disabilities/ssd-online) (<https://www.collegeboard.org/students-with-disabilities/ssd-online>); this may be different than what you did in Fall 2015.

- **February 26, 2016 at 5:00 PM:** Deadline for students to be pre-identified and identified as paper/pencil on the Secure Site for barcode labels, initial materials, and accommodated materials.

K-2 Early Literacy and Numeracy

- **February 26, 2016 at 5:00 PM:** Students to be pre-identified on the Secure Site by this date will be available in eDIRECT **starting March 4, 2016**. Students can continue to be pre-identified on the Secure Site and they will be loaded daily into eDIRECT.

MI-Access P and SI

-  **February 26, 2016 at 5:00 PM:** Deadline to enter the number of administrators administering the assessment through the Secure Site on the Initial Material Orders page.
