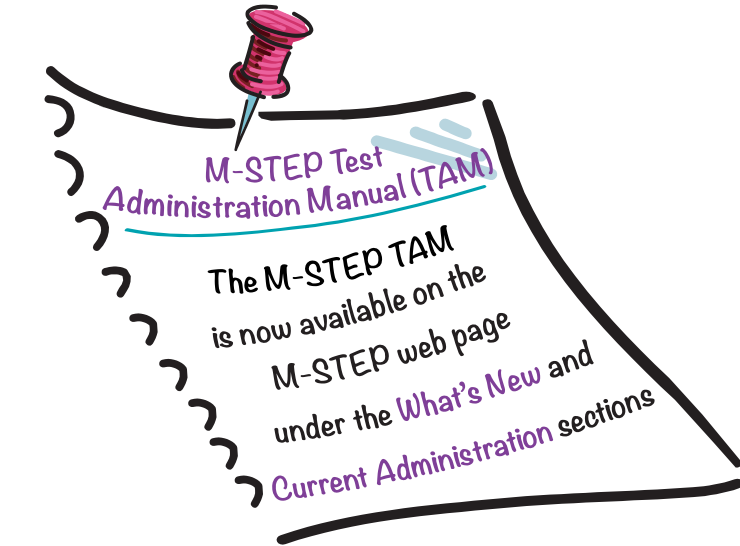

Information on SAT™, PSAT 8/9™, and PSAT10™ provided by the College Board

### English Learner Supports

English learners in Michigan taking the state-provided PSAT 8/9, PSAT 10, and SAT during the school day will have access to testing directions in Spanish, Arabic, Haitian Creole, Mandarin, Portuguese, Polish, Russian, and Vietnamese. Additional languages can be supported with “on the fly” translations by district-approved translators. English learners will also be able to use approved word-to-word bilingual glossaries. The assessment results, when these supports are used, will now be college and scholarship reportable and do not require an accommodation request in Services for Students with Disabilities (SSD) online. These students can test in the standard testing rooms.

Students may not bring their own glossaries on test day. The glossary used must be from the approved glossary list and distributed by the school on test day, after it is checked to make sure nothing has been added or inserted in the book. Schools can also provide glossaries, if needed.

The list of approved bilingual glossaries and translated test directions can be downloaded from the [Michigan College Board Website](http://www.collegeboard.org/michigan) (www.collegeboard.org/michigan).

The translated test directions are not Michigan-specific, but will provide all relevant directions for students. However, the directions do not include specific timing information, so test center supervisors and associate supervisors should make sure students understand they should pay attention to the timing instructions provided verbally and written on the board.

### Training

Over 65 percent of SAT test center supervisors have completed the online training...thank you! A reminder that the PSAT training will be available in the same online learning system in early March.

**TIP:** Be sure to include your test center number when first accessing the training.

### PSAT 10 Student Guides

PSAT 10 Student Guides will arrive March 6-8, 2017, and you should receive enough for every 10th grade student. You may pass these out to students as soon as you receive them. The quantities shipped to schools are based on last year’s PSAT 8/9 testing cohort and not the number of students pre-identified for PSAT 10. For some schools, particularly those that may not have tested 9th graders last year, the estimated quantity you receive may not be enough. ## Recently Asked Questions . . .

### Since we now have to create seating charts for all state assessments, is there a certain spacing requirement?

Seating charts have been required during testing since Spring 2016. You can find all of the requirements for seating charts in the [Assessment Integrity Guide \(AIG\)](#) (pg. 13). There are templates available in Appendix C. The AIG reflects the minimum requirements—some assessments such as the SAT and ACT WorkKeys have specific spacing requirements that must be adhered to. The Assessment Integrity Guide can be found on any of the assessment web pages.

### We missed the initial material order deadline. How do we get materials for testing?

Schools will have an opportunity to order additional testing materials about two weeks prior to each testing cycle. You can check the Important Dates document on each assessment web page or check the Home/Announcement page of the Secure Site once you are logged in.

## Recently Asked Questions . . .

### Are students who are repeating grades 9 or 10 expected to take the PSAT 8/9 or PSAT 10 again?

Yes. Students repeating grades 9 or 10 who previously took the PSAT 8/9 or PSAT 10 are expected to take the test again.

### If we have a student who needs a human reader for the online test, how would we accomplish that?

The student must test alone or in an area where they will not be heard by other testers. The proctor reads the item from the screen.

### Can Test Administrators and Proctors have water bottles during M-STEP testing?

Yes.

### Can Test Administrators and Proctors have cell phones during M-STEP testing?

Yes. Students' electronic devices should be powered down and out of reach, but there is no such restriction on school staff. The [Assessment Integrity Guide](#) (page 14) advises not using phones while monitoring students because conversations, e-mail, and web-browsing are distractions that would keep Test Administrators and Proctors from giving their full attention to testing. Most modern phones include cameras and video cameras, which are a security threat in the testing room, and taking pictures of the test or testing students is prohibited. For these reasons, it is usually best to avoid using the phone during testing, absent a need such as calling for assistance.
