### WIDA ACCESS for ELLs Scores and Reports


Results from the Spring 2016 WIDA ACCESS for ELLs and WIDA Alternate ACCESS for ELLs will be available **June 14th, 2016**. Educators will be able to access scores and reports in the following ways:


- **June 14, 2016** – Electronic reports will be available for download via WIDA AMS. - **June 17, 2016** – Individual Student Reports, Student Roster Reports, School Frequency Reports, and District Frequency Reports will be shipped to arrive in districts by this date. More information will be forthcoming related to the availability of these additional reports and scores. However, educators are encouraged to retain a copy of the list of students who appeared in their Not Tested lists. This will aid districts in tracking the continued resolution of many of these scores.

## **Data Informed Accessibility – Making Optional Needs-based Decisions (DIAMOND) Project**

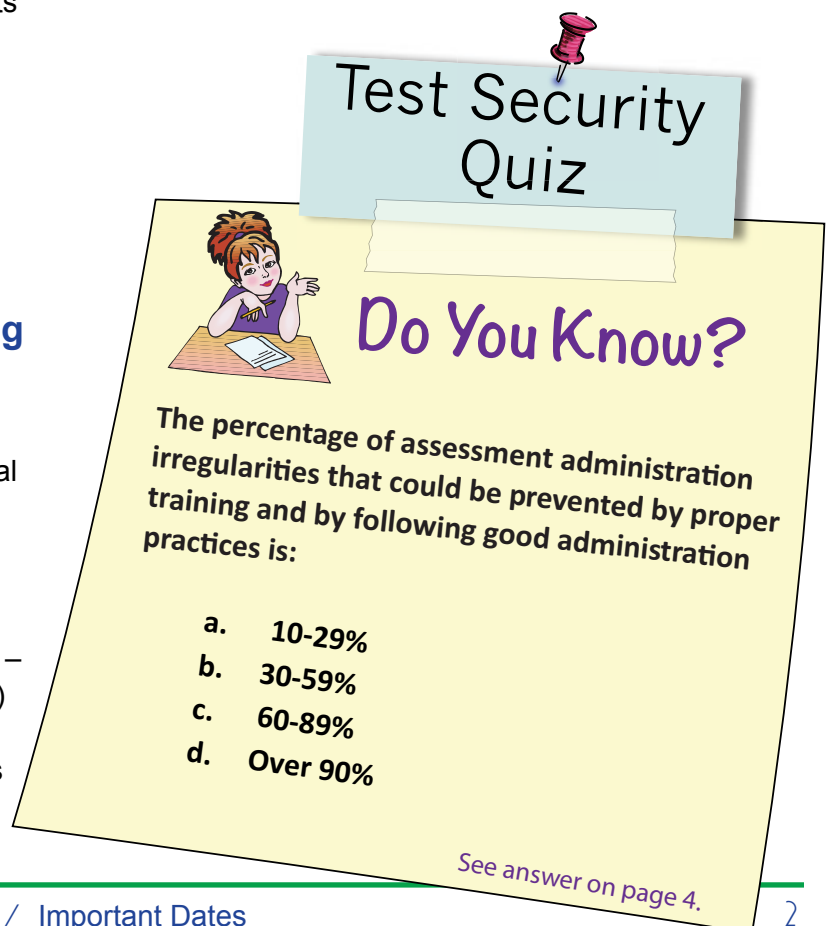

## Accountable Students & Test Verification Windows for Grades 3-8 and HS

Please remember to complete the Accountable Students & Test Verification tasks to ensure your school's data are accurate for assessment and accountability reporting.

It is **strongly suggested** you view the **Accountable Students & Test Verification – All Assessments** instructions on the [Secure Site Training web page](http://www.michigan.gov/secaresitetraining) ([www.michigan.gov/secaresitetraining](http://www.michigan.gov/secaresitetraining)) under the **Quick Reference** section. This document will walk you through the process, giving pointers on what to look for, how to report issues, and how to fix an error when possible, along with helping to identify possible issues.

## Verification of Enrollment for Accountability Purposes

- Review your school's list of Accountable Students
- Review the demographics of the students on your school's list of Accountable Students
- Add/withdraw students, or make changes to their demographics, as necessary using a SRM (Student Record Maintenance) upload to the MSDS (Michigan Student Data System) with an "As of Date" on or before May 27, 2016 **AND** certified by 5:00 PM on June 22, 2016.

- The MSDS End-Of-Year Collection will **NOT** update enrollment and demographic information for assessment and accountability reporting. Please communicate this to your district's MSDS person.

## Verification of Answer Documents

Verification of Answer Documents will be available:

- **SAT, PSAT 8/9 (grade 9 only), PSAT 10, and WorkKeys:** **Now closed**
- **M-STEP and MI-Access:** June 15, 2016 at 8:00 AM – June 22, 2016 at 5:00 PM

## For M-STEP and MI-Access

- Review the list of answer documents received to ensure all tests taken are listed and submit "Missing Test" or "Missing Student" appeals as needed.
- Review the list of students flagged for Prohibited Behavior and/or Nonstandard Accommodations and submit appeals if these flags were set unintentionally.
- Review the lists of students flagged for Out of Level or taking an Alternate Assessment Not SE (i.e., took MI-Access but are not flagged as Special Education).
  - ♦ Corrections to students' enrolled grade or the addition of a Special Education flag can be done using a SRM upload to MSDS with an "As of Date" on or before May 27, 2016 **AND** certified by 5:00 PM June 22, 2016.

## Verification of Students Not Tested

The Verification of Not Tested will be available:

- **PSAT 8/9, PSAT 10, and WorkKeys:** N/A – These assessments will **NOT** be used in accountability and therefore do not have a verification of Not Tested window.
- **SAT, M-STEP, and MI-Access:** June 15, 2016 at 8:00 AM – June 29, 2016 at 5:00 PM.

## For SAT, M-STEP, and MI-Access

- Review the list of students flagged as Not Tested and submit a Not Tested Reason for each unaccounted test (including any necessary documentation such as a doctor's note for a Medical Emergency Not Tested Reason)
- For students flagged as Not Tested due to UIC issues (testing records [answer documents] and enrollment records [MSDS] are using different UICs), the multiple UICs need to be resolved in MSDS by 5:00 PM June 22, 2016 or the student will be considered not tested.

Please note that for Shared Educational Entities (SEEs) and Specialized Shared Educational Entity (S2E2s), the district and school operating the SEE building or S2E2 classroom program must be the one that manages all elements of the of Accountable Students and Test Verification functions on behalf of the resident districts that participate and send students to the SEE/S2E2.

### Quiz Answer:

Correct answer is **D**.

Most test irregularities happen because test administration staff have not reviewed the guidelines and procedures in test administration manuals and other supporting documentation. Make sure all test administration staff have been properly trained and have signed the OSA Security Compliance Form prior to testing.

## SAT Corner

Information on SAT™, PSAT 8/9™, and PSAT10™ provided by the College Board

### Reporting Reminders for Educators

To access scores, you must have a **College Board Professional account and have been granted access to reporting by your school's Data Access Tool Manager**. Each district/school must have at least one Data Access Tool (DAT) Manager. This person is responsible for assigning access to educators within the school. The DAT Manager will assign a user role to each educator. The online reporting portal consists of two areas:

- **Report Center:** Reporting tools allow educators to configure and run online reports, apply filters for data analysis, and print student reports
- **Download Center:** Data files available to manage electronic score downloads – manual and automatic

The DAT Manager does not automatically have access to the Reporting portal. The DAT Manager will need to assign themselves roles in the portal as well if they need to review scores. If you are unsure if your school has a DAT Manager established, contact Jason Feig ([jfeig@collegeboard.org](mailto:jfeig@collegeboard.org)) or Ted Gardella ([tgardella@collegeboard.org](mailto:tgardella@collegeboard.org)) so that we may verify and provide access if needed.
