**EXTENDED TRANSPORTATION PERMIT**  
for the movement of  
**UP RAW FOREST PRODUCTS**

**Conditions and Restrictions**

**All application and permit fees are nonrefundable, pursuant to Act 561 of PA 2002.**

2. The permittee shall be responsible for damages to the highway, to persons and to property caused by or arising from operations covered by this permit. The permittee shall indemnify and save harmless the Transportation Commission, the department and all of their employees from any and all suits, claims, and damages of every kind arising out of, under or by reason of this permit, or from operations covered by this permit.
3. The driver of the vehicle shall carry a paper copy of the permit in the vehicle to which it applies and shall have it available for inspection by any police officer or agent of the Department of Transportation. The driver shall stop at all highway weigh stations for permit inspection.
4. Insurance coverage required in the law of this state shall be in effect for moves operating with an over weight or over size permit.
5. Any of the following actions shall immediately void the permit and subject the applicant to appropriate legal action:
  - (a) Misrepresentation of information set forth in an application for permit;
  - (b) Any operation on state trunkline highways beyond the size or weight limitations shown on the permit;
  - (c) A change or erasure on a permit.

6. Permits are not valid for periods extending beyond the expiration date. Extended permits will not be issued for a period of less than a year.
7. Permits will be issued only for vehicles owned by the applicant or operated under a bona fide lease agreement. Each vehicle with a combination of vehicles (tractor, semi-trailer, lowboy, etc.) and each object being moved must have a valid permit.
9. This permit is not valid on county roads or city streets. If the equipment is to be moved on any county road or city street, permission must be obtained from the appropriate authorities.
10. Permits not valid on highways or structures which are posted for lighter than legal loadings if the vehicle exceeds axle loadings as posted. Permits are not valid for over weight when weight restrictions are in effect. Over weight vehicles and loads are not to cross bridges listed on attached bridge list (form 2282A).
14. This permit is for the transportation of only the over size or over weight vehicles and loads listed on this permit.
24. Prior to any movement, it is the applicant's responsibility to determine whether there are any construction bulletins issued by this Department which restrict the dimensions or weight within the limits authorized by the permit. Knowledge of issued construction bulletins will be presumed. Movements which exceed the limits prescribed will be invalid under this permit. **ADDITIONAL CONDITIONS AND RESTRICTIONS APPLICABLE TO THE MOVEMENT OF UP RAW FOREST PRODUCTS**

1. Products carried will be limited to those authorized by Wisconsin's raw forest product permit. Products presently described as poles and pulpwood including logs. Wood chips to be excluded.
2. Movement will be restricted to straight trucks or truck and trailer or semi-trailer only.
3. Permits will be valid for Interstate and Intrastate movements if the vehicle registration allows. However, interstate movements for Wisconsin to Michigan and Intrastate movements within Michigan will be valid only to forest products terminals and only on the following specified routes:

Wisconsin to Amasa – US -141; Wisconsin at Hurley to Bessemer – US-2; Wisconsin to Sagola – US-141 to US-2 to M-95; and/or M-95, and/or US-8 to US-2 to M-95, and/or US-2 at Iron Mountain to M-95; Wisconsin to Quinnesec – US-141 to US-2, and/or US-8 to US-2, and/or US-2 at Iron Mountain; Michigan-Wisconsin line at Menominee to Birch Creek – US-14.

4. Weight allowances will be limited to the following:

5. This permit is not valid during spring weight restrictions.
6. Hours of operation for permitted loads will be 24 hours per day, 7 days per week, including holidays, subject to weather or other unusual operational situations with respect to the trunkline.
7. Vehicles shall be registered as required by Michigan statute and will not violate any statute or ordinance, rule or regulation of any state agency or subdivision of the state. Vehicles shall comply with all statutory provisions as to other permits, licensing, motor vehicles equipment and operation. This permit does not exempt the vehicle from being registered for the maximum gross weight as required by Sections 275.801 through 257.803b Act 300 P.A. of 1949, as amended.
8. Permit is valid only if favorable driving and traffic conditions prevail.
