Authorization (Z4) under Contract (2016-0369) between MDOT and Surveying Solutions, Inc., will provide for as-needed construction staking services to be performed for the reconstruction of US-23 from M-14 to M-36 in Washtenaw and Livingston Counties. The work items will include establishment of horizontal and vertical alignments, documentation of drainage and subsurface changes, and preparation and documentation of project records. The authorization will be in effect from the date of award through July 12, 2019. The authorization amount will be \$519,881.38. The contract term is July 13, 2016, through July 12, 2019. Source of Funds: Federal Highway Administration Funds, State Restricted Trunkline Funds, or local funds, depending on the particular project authorized.

2. *HIGHWAYS (Maintenance) - State Trunkline Maintenance
Contract (2017-0203) between MDOT and the Presque Isle County Road Commission will provide for statewide trunkline maintenance to be performed for a five-year period. The contract will be in effect from October 1, 2016, through September 30, 2021.

Public Act (PA) 17 of 1925 authorizes MDOT to contract with cities, villages, and boards of county road commissioners for the construction, improvement, and maintenance of state trunkline highways. Under the terms of the standard maintenance contracts, the cities, villages, and boards are reimbursed for audited labor, equipment rental, and material charges in accordance with the provisions of the contracts. This maintenance contract was not competitively bid but was negotiated with the local unit of government. MDOT has found that such negotiated agreements are in the public interest and has transmitted those findings in accordance with Section 11c of 1951 PA 51, MCL 247.66a(c).


