**Board action on agenda item:** The Board approved the minutes of the November 15, 2018 meeting as submitted. Moved by Matuzak; supported by Pero. Ayes: Shinkle, Matuzak, Pero, Bradshaw. Nays: None. Motion carried.

**Agenda item:** Consideration of whether two recall petitions submitted by Dean Schuette on November 16, 2018 factually and clearly state each reason for the recall of Jackson County Sheriff Steven Rand.

The reasons for recall printed in the heading of the first petition are as follows:

On February 20, 2018 the Jackson County Board of Commissioners passed Resolution 02-18.9, requesting Steven Rand resign from the office of Sheriff, effective immediately.

**Board action on agenda item:** The Board determined that the first recall petition, identified as Petition No. 1, filed by Dean Schuette on November 16, 2018 factually and clearly states each reason for the recall of Jackson County Sheriff Steven Rand. The second recall petition was verbally withdrawn by Mr. Schuette, the petition sponsor.

First, based on an examination of the election returns received by the Secretary of State for the November 6, 2018 general election, the Board certified that the attached report is a true statement of the votes cast at the election for the offices certified by this Board. The Board further certified that the persons named on the attached listing were duly elected for the indicated offices, and Proposals 18-1, 18-2, and 18-3 were adopted.
