The State Tax Commission (Commission) has received a resolution from the City of Oak Park regarding the transfer of Obsolete Property Rehabilitation Certificate Number 3-15-0018, issued to The Loop Apartments Community, LLC, located at 15205-15423 Northgate & 25430-25840 Lincoln Terrace (aka Greenfield Road) in the City of Oak Park.

Public Act 146 of 2000, the Obsolete Property Rehabilitation Act (Act), provides for the transfer of a certificate by the legislative body of the qualified local governmental unit. The Act does not require action by the Commission following the transfer by a qualified local governmental unit. However, the Commission acknowledges the transfer of Certificate number 3-15-0018 as approved by the City of Oak Park and will change our records to reflect this transfer.
