APPROVED VOCATIONAL REHABILITATION FACILITIES

The Michigan Workers' Compensation Agency has established standards for approval of rehabilitation facilities that serve injured employees. The standards reflect practices and guidelines that are consistent with the recognized and current expectations of the vocational rehabilitation profession. The primary obligation of approved facilities and the professionals providing vocational services will be the rehabilitation of the employee, who is the client.

It is not required that rehabilitation facilities in Michigan obtain agency approval to serve injured workers. However, if the director or the director's representative finds it necessary to order vocational rehabilitation evaluations and/or services pursuant to MCLA 418.319 and R408.45, such referrals must be to an agency approved facility.

- o The following rehabilitation facilities provide comprehensive vocational rehabilitation services, including vocational evaluation and assessment, counseling and guidance, retraining support, job analysis, job development, competitive job placement services, and accommodation assistance. Each facility should be contacted individually as necessary to verify the scope of services offered and fee structure.
