**Background:** "Vision 100" serves as a mechanism for demonstrating PATH program

performance for Department of Human Services (DHS) local offices and their MWA partners. It will also empower DHS and MWA offices in proactively engaging families, enhancing local partnerships and leveraging innovation.



The "100" of "Vision 100" stands for (1) the goal of 100 percent work participation for Michigan's work-ready PATH participants, and (2) supportive case management for 100 percent of Family Independence Program (FIPs) who are not work-ready. Case management will include removal of barriers to employment and work readiness to quickly move these participants toward sustainable work.

**Policy:** 

Effective February 4, 2014, DHS decided that further clarification was needed regarding the distinguished "Vision 100" Governor award criteria. This particular award will be given **annually** and chosen by DHS Central Office staff based on nominations submitted by the DHS Business Service Center (BSC) directors.

The ideal candidate for the Governor's award would:

- Have distinguished herself or himself as an outstanding achiever and leader;
- Should not have any recent history of fraud, Intentional Program Violation, recoupment;
- Was referred to the PATH program on or after January 2, 2013, and participated and completed the 21-day Application Eligibility Period (AEP);
- Be dedicated to the "Vision 100" Governor Award values. (The Vision 100 Governor Award is bestowed by the Governor of Michigan and Director of Human Services to an individual or individuals who have reduced and/or removed significant roadblocks to obtaining and sustaining employment. The recipient(s) of the Vision 100 Governor award are determined and dedicated individuals who are successfully on their "PATH" to self-sufficiency);
- FIP case should be closed, Extended Family Independence Program (EFIP) or reduced due to earned income; and
- Have been employed at least three consecutive months and must be employed at the time of the ceremony.

Nominees must meet all the criteria identified and those making nominations should identify/ensure the award criteria applies to all viable candidates (written nomination) submitted to Field Operations Administration (FOA). The deadline for Nominations for Vision 100 Governor's Award is June 16, 2014.

We encourage local MWA/DHS offices to continue to honor PATH clients with a "PATH Achiever's Award" that is chosen by local DHS/MWA directors, on no less than a yearly basis. The same principles would apply in the instance, the client will have overcome obstacles to achieve self-sufficiency. Nomination selections **do not** have to come to DHS FOA for any approvals; it will be local office discretion.

Team meetings between MWA and DHS should continue to be held. However, a Vision 100 plan will not be required at the State level.

**Action:** MWAs should adhere to the instructions of this policy.
