Background: This policy change redistributes FY 2015 PATH GF/GP funding in the

amount of \$135,333. The funding will be distributed to Area Community Services Employment and Training (ACSET) in the amount of \$105,575 and Oakland County Michigan Works! in the amount of \$29,758. This funding

was de-obligated from the Southwest Michigan Works!.

Policy: The WDA will redistribute \$135,333 in FY 2015 GF/GP PATH funding from

Southwest Michigan Works!. The funding is being distributed based on ACSET's and Oakland's request for additional funding to close out the fiscal

year. This funding must be spent by September 30, 2015.
