Re: WARN Act Notice/Mass Layoffs Occasioned by Sale of Elmwood Geriatric  
Village, Inc.

Dear Ms. Beckhorn:

This notice is being provided pursuant to the Worker Adjustment and Retraining Notification Act (“WARN”), 29 USC 2101, *et seq.*, which requires employers to give official notice to certain governmental units or officials of a pending mass layoff. Bortz Health Care has decided to sell Elmwood Geriatric Village, Inc., and will permanently lay off employees accordingly. While some details need to be worked out, it would appear that the sale is expected to be completed on June 30, 2013, and layoffs will become effective immediately thereafter. The address of the affected facility is:

The layoffs at this facility will affect both employees not represented by any union and employees represented by the SEIU Healthcare Michigan. The chief elected official of this union is Margaret Faville. She may be contacted at (313) 965-9450. The job titles affected by the layoff and the number of affected employees in each job classification are listed in the attached document.

Employees not represented by the union do not possess any bumping rights. Employees represented by the union possess bumping rights under contract. However, the collective bargaining agreement does not provide bumping rights allowing transfer of employees between Bortz Health Care facilities. Additionally, at present, the company does not know which, if any, employees will be offered continued employment with buyer.


