Due to the non-payment of outstanding invoices of \$18,256,523.70 of which \$9,363,070.04 is greater than 90 days past due, effective August 12, 2013, Sodexo will no longer perform services at the Detroit Public Schools account. Thus, on or about August 12, 2013, Sodexo will close its operation at this facility and the employment of individuals there by Sodexo will be discontinued.

This notice of facility closing is being provided to you in compliance with the federal WARN Act (Worker Adjustment and Retraining Notification Act). This information is based on the best information currently available to us, but may change due to subsequent events beyond our control.
