

QUARTERLY NURSING HOME STAFF REPORT

(FY2005 Appropriation Bill - Public Act 349 of 2004)

Section 708: Nursing facilities shall report in the quarterly staff report to the department, the total patient care hours provided each month, by state licensure and certification classification, and the percentage of pool staff, by state licensure and certification classification, used each month during the preceding quarter. The department shall make available to the public, the quarterly staff report compiled for all facilities including the total patient care hours and the percentage of pool staff used, by classification.
