

## CERTIFIED END-USER LIST

PLACEMENT ON THIS LIST DOES NOT IMPLY AN ENDORSEMENT BY EGLE. SECTION 16902 OF PART 169, SCRAP TIRES, OF THE NATURAL RESOURCES AND ENVIRONMENTAL PROTECTION ACT, 1994 PA 451, AS AMENDED, PROHIBITS A PERSON FROM DELIVERING TIRES TO A LOCATION THAT IS NOT IN COMPLIANCE WITH THE REQUIREMENTS OF PART 169.
