**Section 677 of 2011 Public Act No. 63 requires the Department of Human Services (DHS) to report the following information on a quarterly basis:**

**1. Current percentage of FIP cases involved in JET employment activities:**

At the end of the third quarter of FY 2012, the current percentage of FIP cases “involved in JET employment activities” for FY 2012, year to date (October 2011 – June 2012), is **49.8%**. The table below provides a break-down of participants coded as “Work First” and includes all FIP recipients (federal and state funded) who attended orientation and started an activity. The table gives the percentage for each month of FY’12 by MWA location along with a monthly statewide average.

At the end of the third quarter of FY 2012, the current percentage of FIP cases that meet federal work participation requirements for FY 2012, year-to-date (October 2011-June 2012), is **39.89%**.
