Promoting Michigan's dialogue on workplace safety and health:

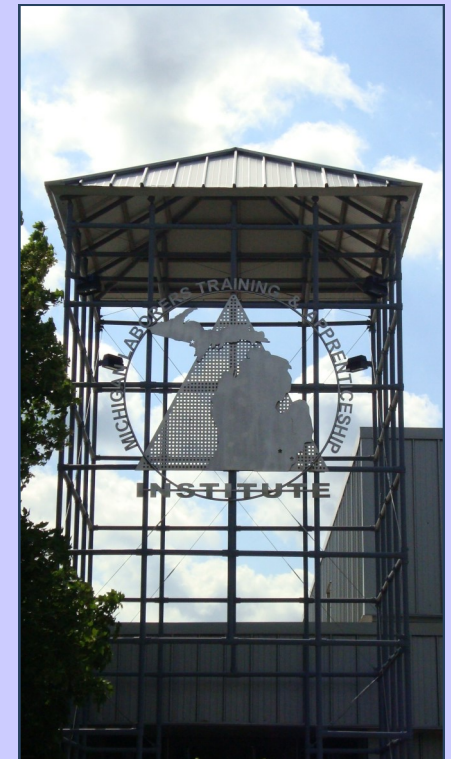
- MLTAI will speak, exhibit, or appear at MIOSHA's conferences, local meetings, and "Coffee with MIOSHA" events when requested.

Areas of Emphasis:

- **Commercial Construction:** A Laborer who works in this area of construction may tend carpenters, tend masons, place concrete or work on site preparation.
- **Highway Construction:** Laborers' working in this area of construction may work with operating engineers to get final grade, they may install underground drainage systems or place concrete or asphalt. Laborers' are also used to place barricades and direct traffic.
- **Underground Construction:** Laborers' working on an underground crew may install water distribution systems, natural gas distribution systems, sewer systems, storm drainage systems, telecommunication cable or work on tunneling projects.
- **Environmental Remediation:** In this category a laborer may remove asbestos, clean up hazardous waste sites, remove lead based paint or work on a nuclear power plant decommissioning project. Laborers' working in this category are required to be formally trained in the area in which they work and adhere to strict safety requirements.
