

COVID-19 Response: Use this checklist as a starting point to plan on-site visitation for youth in CCIs.

Did you...

Provide visitors the signs and symptoms of COVID-19, who to notify if they develop signs or symptoms of COVID-19 at the facility, or within 14 days of visiting the facility, appropriate methods for hand washing and sanitization techniques, handling masks and face coverings and containing coughs and sneezes and social distancing recommendations?	<input type="checkbox"/>
Provide the specific information covered in Section 1a-vii of the MDHHS Director's Executive Order?	<input type="checkbox"/>
Designate visitor entrances that allow proper screening?	<input type="checkbox"/>
Post signage at any visitor entrance instructing visitors to be assessed for symptoms of COVID-19 before entry? Post signage instructing persons who have symptoms of a COVID-19 infection to not enter the facility?	<input type="checkbox"/>
Establish a protocol to perform a health evaluation of visitors each time a visitor seeks to enter the facility, and deny entry to those visitors who do not meet the evaluation criteria?	<input type="checkbox"/>
Provide supplies for respiratory hygiene and cough etiquette, including the safe use of alcohol-based hand rub with 60-95% alcohol, tissues, and no-touch receptacles for disposal available within the facility, including intake areas, visitor entries and exits, visitation rooms, common areas, restrooms, and dining areas?	<input type="checkbox"/>
Did you restrict visitation to designated areas only?	<input type="checkbox"/>
Did you determine visiting hours and inform visitors of the limited number of visitors per resident (2)?	<input type="checkbox"/>
Communicate the need for visitors to wear a mask or face covering as outlined in the Executive Order, 1a-i?	<input type="checkbox"/>
Establish means for visitors to ensure social distancing, staying at least 6 feet away from others, except with the resident they are visiting?	<input type="checkbox"/>
Establish a process for ensuring visitation is prohibited any time aerosol generating procedures or collection of respiratory specimens takes place unless deemed necessary by facility staff for the care and well-being of the resident?	<input type="checkbox"/>
Create a process for cleaning and sanitizing visitation areas in accordance with CDC guidelines prior to and following a visit?	<input type="checkbox"/>
Discourage in person visitors for residents at high risk for severe illness from COVID-19?	<input type="checkbox"/>

Did you...

Provide information about COVID-19 to residents and families, including recognition of signs and symptoms, notification procedures if signs/symptoms develop during or following a visit, hand washing and sanitizing techniques, mask wearing and appropriate containment of coughs and sneezes?	<input type="checkbox"/>
Establish a process for screening of family/household members prior to visit taking place off site?	<input type="checkbox"/>
Designate specific point(s) of entry for residents to use when returning from a visit (same as visitors)?	<input type="checkbox"/>
Establish a process for how returning residents will be screened and evaluated for COVID-19 symptoms, including a temperature check, prior to re-entry?	<input type="checkbox"/>
Communicate restriction of visits to the agreed upon, designated family home or other specified location?	<input type="checkbox"/>
Communicate restriction of visits to occur only with agreed upon, designated family members or other specified person(s)?	<input type="checkbox"/>
Establish a protocol for the resident to be quarantined for 14 days following return if known exposure occurred, but no signs or symptoms are present?	<input type="checkbox"/>
Establish a protocol for the resident to be isolated and tested as required following return if signs/symptoms are present?	<input type="checkbox"/>
Consult with the resident's physician prior to any off site visits for residents at high risk for severe illness from COVID-19 for any limitations?	<input type="checkbox"/>
Establish alternative means for extended visits via electronic platforms when a resident is unable to leave campus?	<input type="checkbox"/>
