RE: Notice of Intent to Submit a Section 1915(b)(4) Waiver Renewal Application for the Healthy Kids Dental Program

This letter, in compliance with Section 1902(a)(73) and Section 2107(e)(1)(C) of the Social Security Act, serves as notice to all Tribal Chairs and Health Directors of the intent by the Michigan Department of Health and Human Services (MDHHS) to submit a waiver renewal application request for the Healthy Kids Dental Program to the Centers for Medicare & Medicaid Services (CMS).

There will be no changes to the Healthy Kids Dental program. The Healthy Kids Dental program will continue to offer a choice of dental plans and an array of dental benefits designed to achieve positive oral health outcomes for Native American beneficiaries in Michigan. The anticipated effective date of the waiver renewal is January 1, 2021.

There is no public hearing scheduled for this waiver renewal application. Input regarding this waiver renewal application is highly encouraged, and comments regarding this notice of intent may be submitted to Lorna Elliott-Egan, MDHHS liaison to the Michigan tribes. In addition, MDHHS is offering to set up group or individual consultation meetings to discuss the Healthy Kids Dental waiver renewal application, according to the tribes' preference. Consultation meetings allow tribes the opportunity to address any concerns and voice any suggestions, revisions, or objections to be relayed to the author of the proposal.
