Dear Tribal Chair and Health Director:

RE: Reimbursement for Pediatric Psychiatric Services

This letter, in compliance with Section 1902(a)(73) and Section 2107(e)(1)(C) of the Social Security Act, serves as notice to all Tribal Chairs and Health Directors of the intent by the Michigan Department of Health and Human Services (MDHHS) to submit a State Plan Amendment (SPA) request to the Centers for Medicare & Medicaid Services (CMS).

The purpose of the SPA is to update the Medicaid State Plan with additional psychiatric services that qualify for increased reimbursement when provided to beneficiaries under the age of 21 years. Rates associated with the eligible services are calculated in compliance with expenditure levels consistent with Public Act 0166 of 2020. The anticipated effective date of the SPA is November 1, 2020. MDHHS expects this change will have a positive impact on Native American beneficiaries by financially supporting the delivery of services.

There is no public hearing scheduled for this SPA. Input regarding this SPA is highly encouraged, and comments regarding this notice of intent may be submitted to Lorna Elliott-Egan, MDHHS liaison to the Michigan tribes. In addition, MDHHS is offering to set up group or individual consultation meetings to discuss the SPA, according to the tribes' preference. Consultation meetings allow tribes the opportunity to address any concerns and voice any suggestions, revisions, or objections to be relayed to the author of the proposal.
