



MDHHS's Rapid Drug Poisoning
Event Surveillance System

Frequently Asked Questions

What is MiCelerity?

MiCelerity is a **real-time drug poisoning surveillance system** released by the Michigan Department of Health and Human Services (MDHHS) in 2020. MiCelerity functions as a repository for events deemed reportable to the Michigan Department of Health and Human Services (MDHHS) under reporting rules 325.76, R 325.77, R 325.78, and R 325.79. The data captured by MiCelerity are automated and are collected via Admission, Discharge, and Transfer (ADT) messages that are exchanged between healthcare facilities and the Michigan Health Information Network (MiHIN) following a healthcare event of interest. The diagnostic information in these messages is scanned for drug poisoning related ICD-10-CM codes; relevant visits are routed into MiCelerity. For instances where event data are not automatically captured, MiCelerity has a manual event entry function to allow users to input drug poisoning events manually.

What is an ADT message?

Admission, Discharge, and Transfer (ADT) messages are electronic messages that are sent within and between healthcare facilities, and between healthcare facilities and third-party entities such as payers and health information exchanges (HIEs). These electronic messages communicate information regarding a patient throughout the course of a healthcare event. ADT messages conform to HL7 standards for the exchange of healthcare information and are widely implemented across healthcare institutes across the world. The Blue Cross Blue Shield of Michigan (BCBSM) Pay-for-Performance (P4P) program incentivizes the sending of ADT messages between Michigan hospitals and the HIE Michigan Health Information Network (MiHIN). What data is captured in MiCelerity?

The data in MiCelerity primarily come from hospital **emergency departments** (EDs). Data from these facilities are captured in MiCelerity if the facility exchanges information with MiHIN and participates in the BCBSM P4P program. Data from other types of facilities, such as long-term care or skilled nursing facilities, may be captured in MiCelerity if the facility exchanges ADTs with MiHIN, participates in the P4P program, and diagnoses a patient with a relevant drug-related ICD-10-CM code. The scope of MiCelerity is considered to be **statewide**. Diagnostic codes from the following types of visits are captured in MiCelerity: drug poisonings (T36-50), drug-related mental and behavioral disorders (F11-F16, F18-F19), neonatal abstinence syndrome and fetal alcohol syndrome (P04, P96), and events related to the toxic effect of alcohol (T51). MiCelerity is an event-based system, with each drug-related ICD-10-CM code constituting one event. MiCelerity captures demographic, geographic, and personally identifiable information for each event.

Is historical data available for analysis?

Historical data is not available in MiCelerity; the system began capturing data in October 2019. Data received by the system prior to February 2020 may be incomplete due to system changes and updates; please take this into account as you view and analyze the data. When looking at trends in your jurisdiction, analyzing data from March 2020 forward will give the most comprehensive and accurate results.

Who can access MiCelerity?

Access to MiCelerity is restricted to state and local health department users whose work is relevant to addressing the overdose crisis in Michigan and healthcare facilities that diagnose drug poisonings and are responsible for reporting them to MDHHS within 5 working days (primarily emergency departments). Due to the sensitive and confidential content of the data captured by MiCelerity, access to the system is currently limited to **3** personnel per local health jurisdiction. Examples of appropriate users at the local health jurisdiction level include: health officers, medical directors, public health nurses, or epidemiologists. Within reporting healthcare facilities, assigned healthcare provider (HCP) users can view all reported events from their facility and are responsible for ensuring that all drug poisoning events that occur at their facility are captured by MiCelerity.

How do I access MiCelerity?

Access to the system will be administered by MiCelerity users at MDHHS. MiCelerity is housed within the Michigan Disease Surveillance System (MDSS). If a user has existing access to MDSS, access to MiCelerity can be obtained by filling out the User Account Access Request Form and submitting the form to MDHHS-MODASurveillance@michigan.gov. Access is reviewed and granted by an administrative user.

If a user does not have an existing MDSS account, access can be obtained by (1) filling out the User Account Access Request Form, (2) submitting the form to MDHHS-MODASurveillance@michigan.gov, (3) requesting access to MDSS through MiLogin, and (4) checking “MiCelerity” under Systems Access Needed on the registration form. How should I use MiCelerity?

Multiple user roles exist within MiCelerity. **Local Health Jurisdiction (LHJ)** users should use the data to monitor drug poisoning events in their jurisdiction. These users can view individual line level data for events within their jurisdiction (e.g. the patient resided in their jurisdiction or sought care at a facility in their jurisdiction) and can export this line level data for analysis. LHJ users can also create aggregate reports in the system based on various drug categories, demographic breakdowns and time periods.

Healthcare provider (HCP) users at the facility level should use MiCelerity to ensure that all drug poisoning events from their facility are being reported to the system. If there are any events that are not automatically captured by MiCelerity, HCP users should report the events to the system via the manual event entry function.

What is Manual Event Entry?

Manual Event Entry is available for drug poisoning events that are not automatically captured by MiCelerity. New events can be created via this function to ensure that the reporting rules regarding drug poisonings are fully met by a facility. This function is only necessary if a facility is unable to exchange information with MiHIN or if a facility discovers that any drug poisoning events that occurred at the facility are not in MiCelerity for any reason. Each individual drug poisoning-related diagnosis code will need to be manually entered as an individual event. It is anticipated that primarily HCP users will utilize this function.

How is this surveillance system different from other systems we may already use?

You may already use the **Michigan Syndromic Surveillance System (MSSS)** to analyze drug poisoning events in emergency departments. MiCelerity differs from MSSS in the following ways: it is drug poisoning specific; it provides a way for healthcare facilities to automatically report drug poisoning events from their facility, thus fulfilling the mandatory reporting requirements; it captures more detailed data including patient-identifying information, allowing for linkage projects and the identification of multiple drug poisoning events per individual; the scope is considered to be statewide without any unique facility onboarding; all events that are captured by the system include diagnostic information.

Is there anything else I should be aware of before using the system?

The data captured within the system is sensitive and confidential as it includes personally identifiable information regarding substance use. While using MiCelerity, please exercise standard security precautions to protect the information captured by the system, such as not sending line level data via email, not leaving the system open on an unattended computer, only accessing the data on an encrypted computer, and not reporting small numbers in any findings in accordance with MDHHS's and your agency's suppression standards (MDHHS requests suppression of case counts between 1 and 5).

Please be aware that as MiCelerity is a new surveillance system, on-going quality assurance (QA) will be performed during its initial period of use. Issues may arise and will be resolved as quickly as possible. If you encounter any issues in the system, please immediately report them to MDHHS-MODASurveillance@michigan.gov.
