

# MDHHS Personnel – Related Costs – Report #7

(FY2016 Appropriation Act - Public Act 84 of 2015)

**April 8, 2016**

**Sec. 280.** *By the fifth business day of each month, the department shall provide a report to the house and senate appropriations committees, the house and senate fiscal agencies, the house and senate policy offices, and the state budget director that provides all of the following for each line item in part 1 containing personnel-related costs, including the specific individual amounts for salaries and wages, payroll taxes, and fringe benefits:*

*(a) FTE authorization.*

*(b) Spending authorization for personnel-related costs, by fund source, under the spending plan.*

*(c) Actual year-to-date expenditures for personnel-related costs, by fund source, through the end of the prior month.*

*(d) The projected year-end balance or shortfall for personnel-related costs, by fund source, based on actual monthly spending levels through the end of the prior month.*

*(e) A specific plan for addressing any projected shortfall for personnel-related costs at either the gross or fund source level.*

# Monthly Report on Personnel-Related Costs

(FY2016 Appropriation Act - Public Act 84 of 2015)

**April 8, 2016**

Please see the attached report, which contains the information as required by the Public Act. This report contains data through the pay period ending March 26, 2016, which includes 11.7 pay periods in FY2016.

The projected year-end balances are derived by comparing projected expenditures for the fiscal year to an economics base (the portion of a line item that is recognized as personnel-related for purposes of calculating annual economic adjustments). If a line item also contains non-personnel expenses, program managers are responsible for managing within the limitations of the entire line item. They do not have to limit personnel spending to the amount of the economics base.

Some of the former human services line items are projected to have lapses due to a hiring freeze that was not lifted until October 27, 2015. While lapses due to vacancies are expected in FY 2016, we do not anticipate the lapses to carry forward into FY 2017 as vacancies are being filled.
