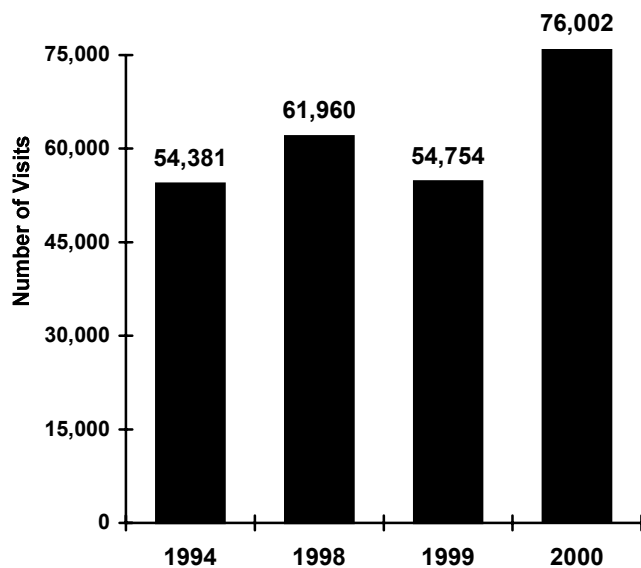

Project Name: Adolescent Health

Target Population:

Youth, ages 10-21 years and their small children.

Project Description:

The program goal is to achieve the best possible physical, intellectual and emotional status of adolescents by providing services that are high quality, accessible and acceptable to the target population. To this end, the Adolescent Health Program administers 20 adolescent health centers which provide primary and preventive health care services and eight alternative model projects, which focus on case finding, referral, screening, health education and referral for primary and other needed health services.

Project Accomplishments for FY 2001:

- Teen health centers served 20,313 teens providing 76,002 services.
- Alternative model projects provided a total of 3,793 educational sessions, reaching 69,922 teens.

Project Goals for FY 2002:

- Continue to facilitate the provision of primary and preventative health services at adolescent health centers.

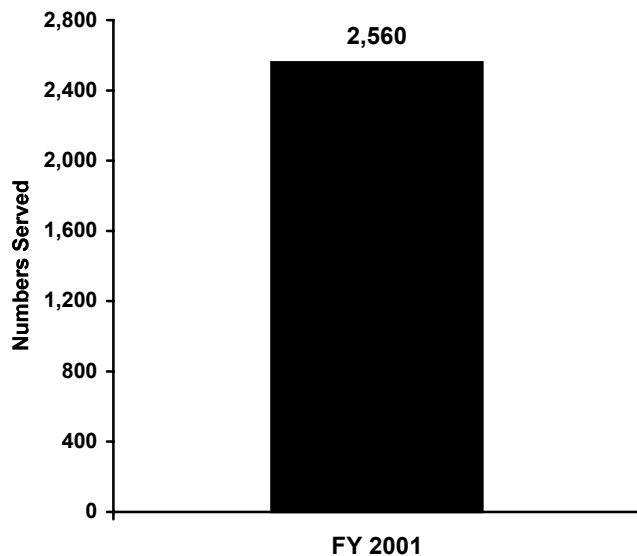

Project Name: African-American Male Health Initiative

Target Population:

African American Males (and females) in Metropolitan Detroit with plans to extend to other areas in the state.

Project Description:

The purpose of this project is to improve the health of African American men (and women) in the city of Detroit and surrounding areas through community based prevention, early detection, health education and care initiatives targeted at diabetes, hypertension, stroke and eye disease. Funds are contracted to the Center for Medical Effectiveness Programs in Diverse Populations at Henry Ford Health System.

Project Accomplishments for FY 2001:

- Provided screenings to 2500 persons for diabetes, hypertension and stroke risk.
- Provided screenings to 60 persons for the eye care services component.
- Conducted diabetes self management education classes to 80 participants
- Provided counseling and educational information to participants who screened moderate or high on the stroke risk assessment.
- Developed partnerships and collaborated to provide 60+ health screenings.
- Works closely with the Racial and Ethnic Approaches to Community Health (REACH) partnerships.
- Working on the development of a Diabetes Report Card to determine what diabetes measures the community regards as important to care.

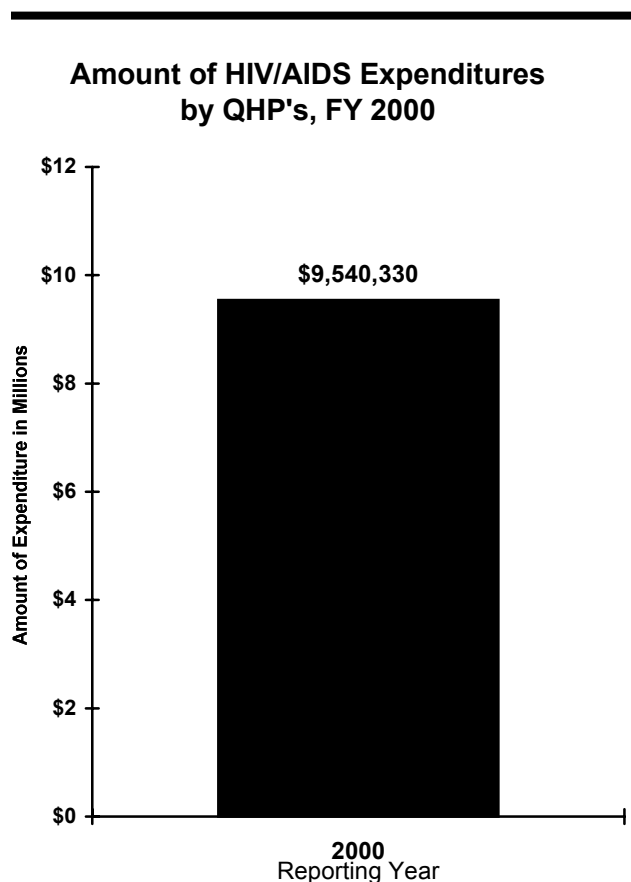
Project Goals for FY 2002:

- Provide screenings for 2,800 persons for diabetes, hypertension and stroke risk
- Provide screenings to 70 persons for the eye care services component.
- Conduct diabetes self-management classes to 90 participants.
- Continue to partner with REACH and other community agencies.

Project Name: HIV/AIDS Medicaid Risk Pool

Target Population:

Medicaid qualified health plans (QHP) enrollees with HIV/AIDS.

Project Description:

MDCH appropriation for 2001 included a special pool of \$912,825 which was supported by Healthy Michigan funding. MDCH portion was \$512,825, with Healthy Michigan fund at \$400,000. The pool was determined by encounter data submitted by the health plans. These funds were in addition to the regular capitation payments that Health Plans receive from the State. The funding was provided in the form of a gross adjustment to the normal monthly funding. Health Plans were required to report their total HIV/AIDS expenditures for provider categories, to determine how the funding was spent. This program is ending in FY 02.

Project Accomplishments for FY 2001:

- \$912,825 was sent out to 22 health plans for HIV/AIDS services to Medicaid Managed Care enrollees.
- All Health Plans reported that their special funding was used as prescribed and spent on physicians payments, in-patient hospital services, out-patient services, HIV/AIDS drugs, and other services specifically for HIV/AIDS patients, such as pathology, lab costs, ambulance and home health, dialysis, behavior health services, hospice, transportation, and etc.
- Each plan indicated spending substantially more than the funding amount on HIV/AIDS.

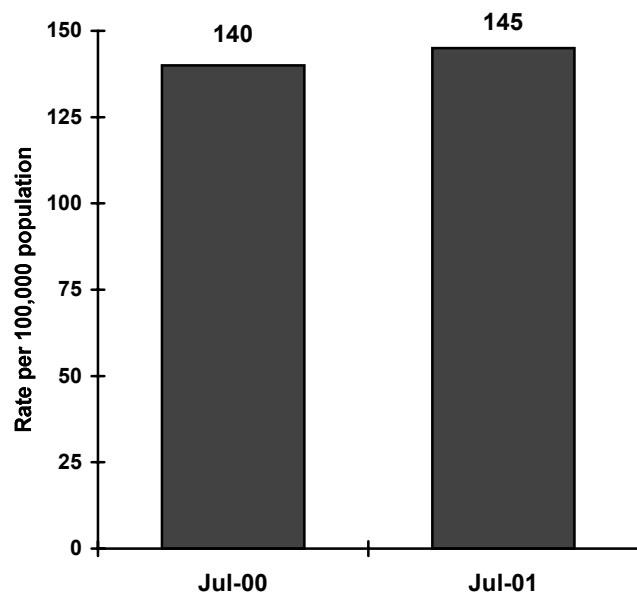

Project Name: AIDS/HIV Reduction

Target Population:

Individuals at increased risk for HIV/AIDS and sexually transmitted diseases; and clients enrolled in the Title X Family Planning Program.

Project Description:

Michigan AIDS Fund provides financial and technical support to community-based providers of HIV prevention services. Targeting is responsive to priorities identified through a community planning process, and as articulated in regional prevention plans.

Michigan Family Planning Program provides services to approximately 167,414 low-income woman and 4,355 men through 50 agencies and 149 clinic sites throughout Michigan. Services include HIV counseling, testing and referral.

Laboratory Testing provides HIV serologic testing (enzyme immunoassay and Western blot) for individuals at increased risk for HIV through a regional laboratory system at Kent County Health Department, and to evaluate methods of HIV drug resistant genotype analysis for monitoring HIV-infected individuals undergoing antiretroviral therapy.

Project Accomplishments for FY 2001:

- Grants ranging from \$5,600 to \$50,000 were awarded to 20 community-based providers of HIV prevention services in Regions 1, 3, 4, 5, 6, 7 and 8. Successfully completed a capacity-building project for Detroit-based AIDS service organizations.
- Funding was provided to 50 family planning agencies across the state for provision of HIV counseling, testing and referral services. A total of 3,362 HIV tests were conducted, of which four (0.1%) were HIV positive. Of all clients tested, 68 percent received their tests results and post-test counseling.
- A total of 40,228 HIV-1 EIA tests were performed at the Kent County regional lab. Of these, 301 were Western blot positive. Also, two commercially available HIV drug resistance genotyping systems are undergoing evaluation by the Lansing lab. This will help determine which system will be implemented for HIV drug resistance testing.

Project Goals for FY 2002:

- Award grants to local providers and offer technical support and capacity building opportunities to ensure sustainable prevention services.
- Perform HIV testing to family planning clients free of charge.
- Perform HIV drug resistance testing for monitoring HIV-infected individuals undergoing antiretroviral testing.

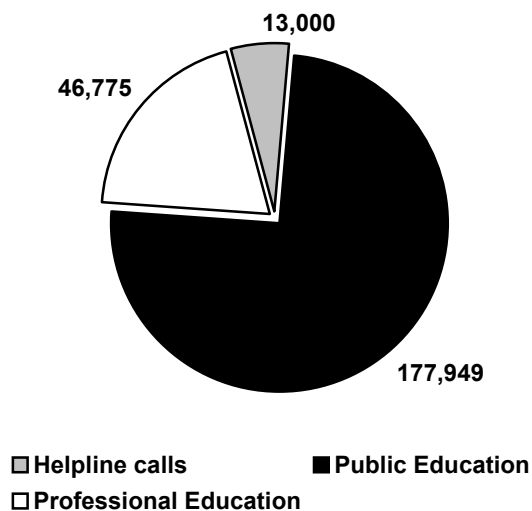

Project Name: Alzheimer's Information Network

Target Population:

The Michigan Department of Community Health contracts with the Michigan Public Health Institute to fund a network of community agencies (ten Alzheimer's Association chapters, the Huntington's Disease Society of American Michigan chapter, and the Michigan Parkinson Foundation) to provide information and referral series through statewide, toll-free help lines, lending libraries of resource materials and educational programs presentations.

Project Description:

The Alzheimer's Information Network strives to enhance the quality of life of persons with dementia in Michigan. It does this through the provision of coordinated, intensive dementia-specific information and referral services and the collaboration and integration of efforts with other agencies and activities. The target populations for these services are persons with dementia, their families and professional care givers. An estimated 219,000 persons in Michigan suffer from dementia.

Project Accomplishments for FY 2001:

- Responded to 12,200 help line calls and made 5,200 follow-up calls.
- Provided 564 presentations for consumers with 13,300 participants.
- Provided 219 presentations for professionals with 3,770+ participants.
- Sponsored 1,700+ support group meetings with 14,700+ participants.
- Provided 9,700+ information packets or individual consultation to consumers and 2,960 packets to professionals.
- Displayed exhibits in 216 sites with 2,464 viewing hours.
- Conducted 111 radio or TV shows.
- Provided 140,249 newsletters to consumers and 40,045 newsletters to professionals.
- Distributed approximately 90,000 pieces of information to the general public.

Project Goals for FY 2002:

- Respond to 13,500 help line calls.
- Provide consumer education through 600 presentations and 13,500 participants.
- Provide professional education programs to 400 professionals and 6,500 participants.

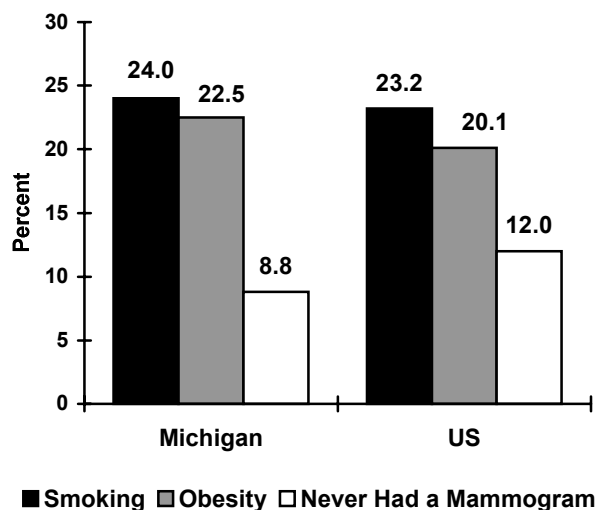

Project Name: Behavioral Risk Factor Surveillance System

Target Population:

Michigan residents 18 years old and older.

Project Description:

This essential public health surveillance system is the only source of data for state-specific estimates of the prevalence of health behaviors, conditions and preventive health practices of Michigan adults that are associated with the ten leading causes of death. Data are collected using a random-digit-dialed telephone survey under a contract with a survey research organization. MDCH staff manages, analyzes and reports the data.

Project Accomplishments for FY 2001:

- Collected data on over 100 variables from 2,500 adult Michigan residents.
- Estimated the adult prevalence of such health indicators as health care coverage, health status, obesity, smoking, physical activity, injury, asthma and cancer screening.
- Prepared annual report of the 2000 survey data.
- Prepared special reports on topics such as prostate cancer, healthy lifestyles and physical activity.

Project Goals for FY 2002:

- Continue surveillance.
- Increase the sample size to 4,000.
- Publish annual summary.
- Perform special analyses of data.
- Publish other analyses of data.
- Respond to special data needs.

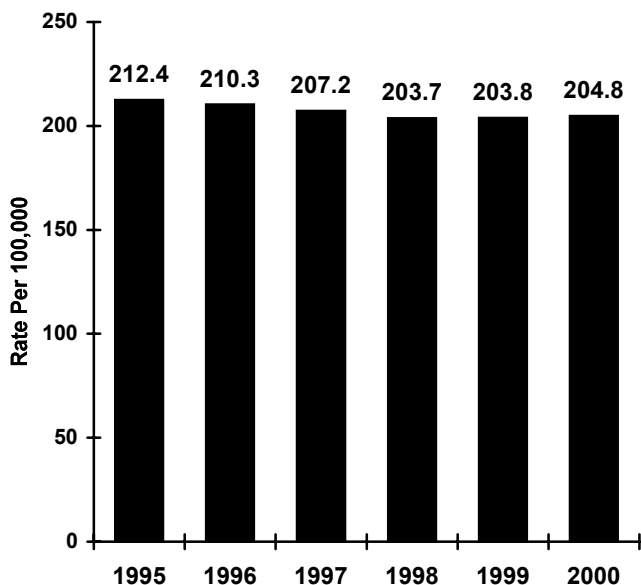

Project Name: Cancer Prevention

Target Population:

Cancer Prevention and Control (including Colorectal Cancer)

Project Description:

The primary objective is to reduce cancer mortality and morbidity in Michigan residents. The Colorectal Cancer program is only funded for one year.

Project Accomplishments for FY 2001:

- Enrolled more than 1,800 low-income women in the breast cancer program that received diagnostic services after an abnormal screening result. Supported mammograms for over 11,000 low-income women aged 40-49. State funds provided a match to enable Michigan to apply successfully for a screening and evaluation program to serve women in three local health jurisdictions.
- The 5-A-Day Grocery Store project distributed more than 120,000 cards or brochures and conducted demonstrations in more than 200 Spartan stores. More than 25,000 people have been reached by the 5-A-Day for Better Health program.
- Drafted a Nutrition Policy and Environment tool in four counties. Assisted in removing an important barrier to patient participation in cancer clinical trials through a voluntary consensus document endorsed by providers, payers, and purchasers, regarding payment of routine patient care costs for patients enrolled in Michigan clinical cancer trials. Marketing to increase participation in the Michigan Cancer Consortium.
- The Karmanos Cancer Institute completed a grassroots project to recruit low-income women into the breast cancer program, a school based tobacco prevention project and a primary care initiative.
- The MSU Institute for Managed Care completed projects to improve Pap smears screening patterns for women at risk, studying characteristics of patients who enter clinical trials, the linking of clinical and cost databases, improving breast cancer screening for nurse practitioners, and interventions directed at high-risk smokers.
- The U of M Comprehensive Cancer Centers completed projects related to testing colorectal cancer screening messages, testing effectiveness of smoking interventions in adolescents and developing electronic communication-based interventions.
- Combined state and federal funds to support a quality improvement initiative with five major Michigan health systems to improve practices related to breast, cervical and colorectal screening and appropriate follow-up care for any identified abnormalities.

Project Goals for FY 2002:

- Increase cancer-screening behaviors of adults to decrease stage at which cancers are diagnosed. Improve appropriate cancer screening practices of health care providers; improve participation in cancer clinical trials; assess timeliness of referrals to end-of-life care and develop improvement plan.
- Increase the number of organizations actively helping to achieve at least one State cancer priorities; increase the number of healthy activity behaviors; increase the number of citizens eating five servings of fruits and vegetables daily.

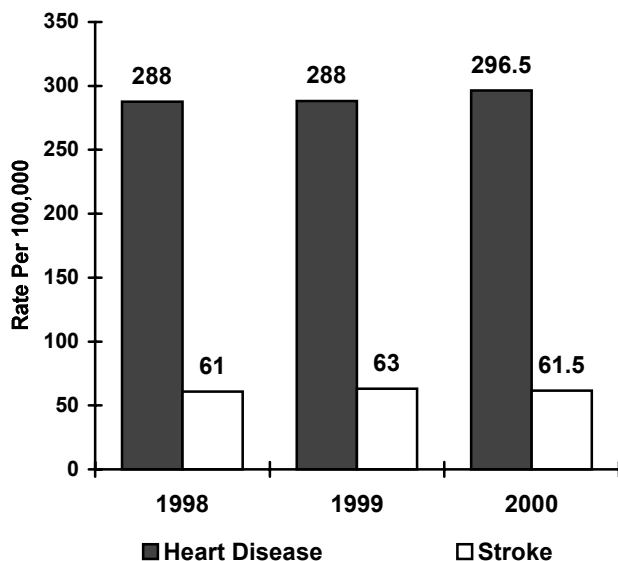

Project Name: Cardiovascular Disease Prevention - Worksite & Community Health Promotion (WCHP)

Target Population:

Services are targeted at adults in both the general public and high-risk groups.

Project Description:

The statewide Cardiovascular Disease Prevention - WCHP program provides a variety of activities in both worksite and community settings, which are designed to reduce the behavioral risk factors that lead to cardiovascular disease (CVD). Program services are provided by local public health jurisdictions and to over 200 private vendors throughout the state. Services include: cardiovascular disease risk screenings/follow-up and educational programs targeted at the major behavioral risk factors for CVD, namely high blood pressure and high cholesterol, smoking, overweight and obesity, poor nutrition and physical inactivity. Other services include community awareness activities, media campaigns, and community health events. A modified version of this program will continue with other funding resources.

Project Accomplishments for FY 2001:

- Funded over 800 worksite grants to provide CVD risk screening/follow-up and risk reduction services to at-risk worksites of less than 500 employees.
- Over 300,000 services were provided in areas of CVD screening/follow-up, risk reduction or awareness/educational programs.
- Conducted three-month follow-up on individuals referred to their physicians for high cholesterol and high blood pressure (20% high blood pressure, 26% high blood cholesterol and 11% undesirable HDL of those screened). One-year follow-up was offered to some of the high-risk individuals.
- Conducted 20 training sessions for 300 professionals who provide screening/follow-up or risk reduction services and conducted 18 vendor on-site reviews of WCHP program services to ensure and maintain quality services.

Project Goals for FY 2002:

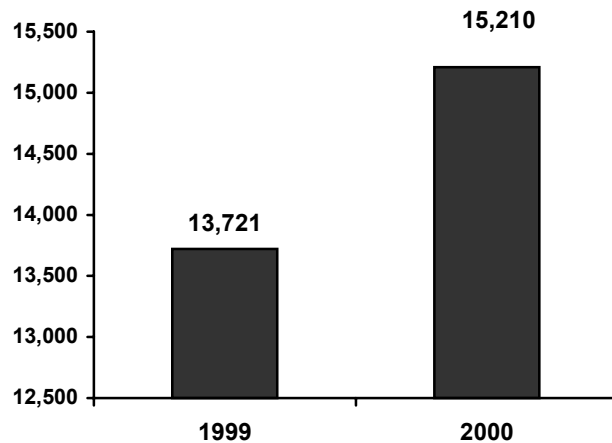
- Continue working with worksites and community groups to prevent and reduce morbidity and mortality related to cardiovascular disease.

Project Description:

Provide a variety of parent support services for families with young children at risk for child abuse or neglect. Some of the program services will be continued and funded through other State Departments.

Project Accomplishments for FY 2001:

- Funded 64 agencies on a broad geographic basis.
- Served 3,000 + families at risk for child abuse and neglect.
- 42 agencies were funded.
- Parent satisfaction for all programs is high.

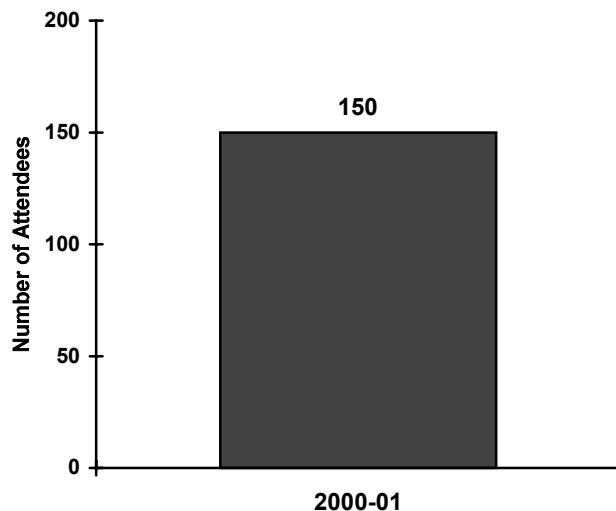

Project Name: Children's Arthritis

Target Population:

6,000 Michigan children with potentially crippling childhood arthritis.

Project Description:

This project aims to prevent needless crippling in children with arthritis. With early, accurate diagnosis and prompt treatment, irreversible joint damage can be completely prevented in most children. The overall objective is to increase awareness of appropriate diagnosis and treatment for childhood arthritis among pediatricians and general medical practitioners in Michigan. The initiative is being carried out by the Arthritis Foundation, Michigan Chapter, under contract with MDCH.

Project Accomplishments for FY 2001:

- A Pediatric Rheumatology CME teleconference was broadcast to 11 Northern Michigan rural hospitals. Approximately 150 health care providers attended.
- Pediatric Rheumatology updates were published in the Michigan State Medical Society journal (circulation 10,000) and the Michigan Academy of Pediatrics summer newsletter (circulation 1,700).
- Pediatric Rheumatology Grand Rounds were held at Hurley Medical Center in Flint and at Beaumont Hospital in Troy. Three other major hospitals have scheduled similar presentations in 2001.
- Several media sources ran stories on the shortage of pediatric rheumatologists during Juvenile Arthritis Awareness Week (WJR-TV12 in Flint, Health Link Magazine, the Grand Rapids Press, and the White Lake Beacon).
- An expert panel has been assembled to develop and publicize a consensus document on diagnosis and management of a child with arthritis.

Project Goals for FY 2002:

- In collaboration with an Expert Panel, develop a consensus document of critical elements of care for children with rheumatic disease in Michigan.
- Develop and implement a plan for dissemination of the consensus document to key primary care provider groups.
- Provide Pediatric Rheumatology Update Grand Rounds in a minimum of two health care sites and a CME video teleconference to a minimum of 10 health care sites.
- Disseminate a packet of information on arthritis in children to 83 Intermediate School Districts (ISD) and to 80 program directors in the Children's Special Health Care Services (CSHCS) network.

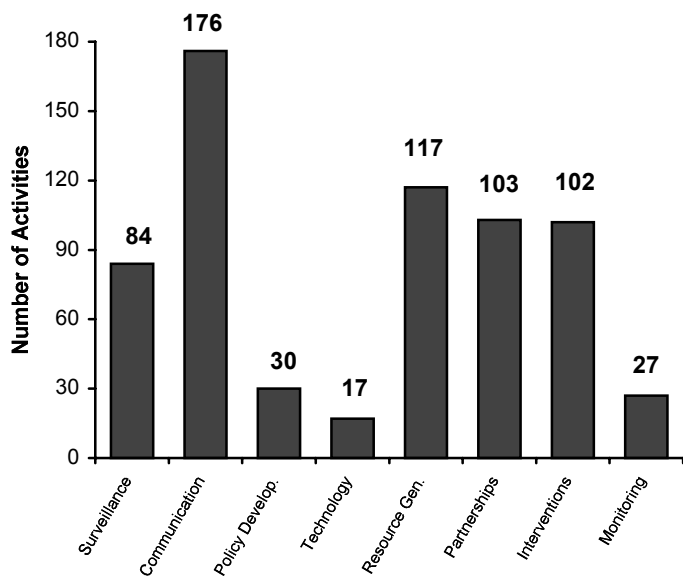

Project Name: Community Health Assessment

Target Population:

Michigan communities working in conjunction with local public health departments (LPHDs).

Project Description:

Public health agencies have a fundamental mission of providing health services to monitor, protect and prevent health problems on a population-wide basis. Resources have been provided to local health departments to carry out community health assessment and improvement activities.

Project Accomplishments for FY 2001:

- 45 local health departments are participating in 62 ongoing community health assessment and improvement (CHAI) initiatives across the state.
- During FY 2001, LPHDs reported addressing a total of 318 community priorities, which include 38 new priorities, identified through their locally based CHAI efforts.
- LPHDs reported more than 650 CHAI related activities that were designed to improve the communities' health and include: data surveillance, communicating health status and resources, policy recommendations/development, use of technology, resource sharing/funding generation, establishing partnerships/forming linkages, initiatives/interventions and monitoring outcomes.
- Staff initiated a revised CHAI reporting process and monitoring system to assist with better identifying the accomplishments and needs of LPHDs working within CHAI.
- Staff provided technical assistance to CHAI contacts in the form of 16 daylong site visits, and by distributing the CHAI newsletter and new orientation manual. In addition, staff piloted an orientation session to 10 newly hired CHAI contacts.

Project Goals for FY 2002:

- Release the CHAI Report 2001 from information obtained through the new CHAI monitoring system to highlight local CHAI activities, accomplishments and future opportunities.
- Increase the number of CHAI groups meeting regionally so as to enhance LPHDs opportunities to share CHAI information and strengthen area relationships.
- Improve educational and training opportunities by evaluating and refining the orientation session, offering two additional sessions, and developing training modules on policy and monitoring areas.
- Improve local CHAI outcome monitoring by enhancing statewide information gathering mechanisms.

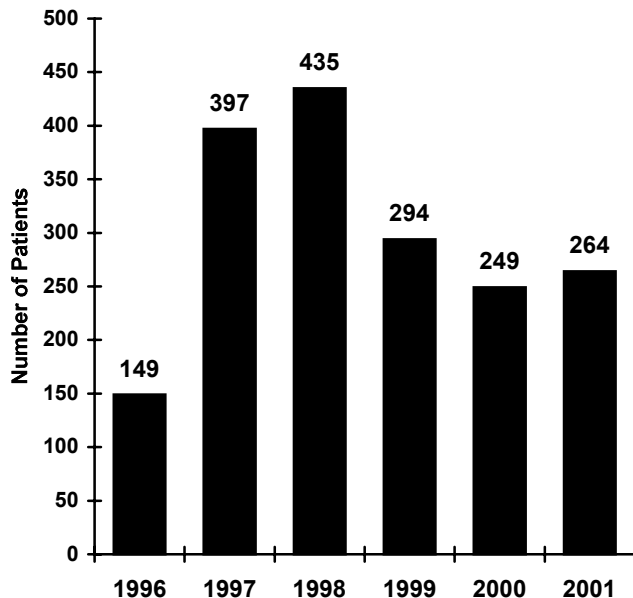

Project Name: Dental Health

Target Population:

Persons who are mentally or physically handicapped, who are medically compromised or elderly.

Project Description:

Through a network of volunteer dentists, eligible patients are referred for comprehensive dental care. Two referral coordinators staff the toll-free phone line, process applications and match patients with volunteer dentists. The budget legislation appropriates the Healthy Michigan Fund allocation to the Donated Dental Service Program administered through the Michigan Dental Association.

Project Accomplishments for FY 2001:

- 264 patients received completed dental care.
- 2,563 dental procedures were provided.
- 615 dentists volunteered.
- 143 dental laboratories volunteered.
- 259 dentists provided patient treatment.
- 91 laboratories provided services.
- \$484,071 worth of dental treatment was donated by dentists, and \$49,905 by dental laboratories, total value donated - \$533,976.

Project Goals for FY 2002:

- Provide 400 disabled, aged and medically compromised individuals with dental treatment.
- To have donated an estimated \$650,000 worth of dental treatment, including \$55,000 worth of donated laboratory fabrications.

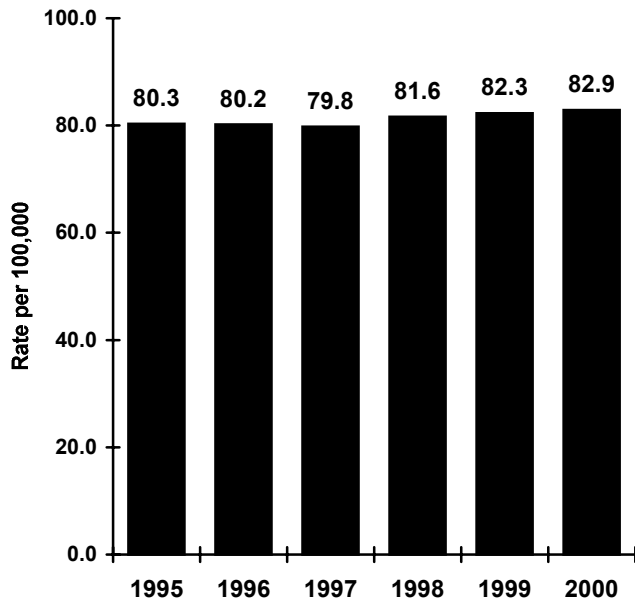

Project Name: Diabetes Local Agreements

Target Population:

Persons with diabetes or kidney disease, at-risk for developing diabetes, or at-risk for developing kidney or other complications of diabetes.

Project Description:

These funds are distributed to agencies providing educational, managerial and other activities intended to reduce mortality and morbidity from diabetes and kidney disease and to improve the quality of life for persons with diabetes and/or kidney disease. The primary recipients of these funds are Michigan's six Diabetes Outreach Networks (DONs), the National Kidney Foundation of Michigan and a few smaller agencies.

Project Accomplishments for FY 2001:

- Through more than 150 partner agencies, Michigan's six Diabetes Outreach Networks (DONs) enrolled and serviced over 4,000 people with diabetes, educated and assisted 50,000 consumers and provided professional education to over 1,400 health care providers.
- Through three campaigns, the National Kidney Foundation of Michigan (NKF) Beauty Salon Initiatives reached nearly 1,000 women; provided education on kidney disease to over 90,000 high school students and 30,000 elementary school children primarily in Detroit; and conducted screening for nephropathy for people with kidney disease to more than 2,000 people across the state.
- The Detroit Diabetes Empowerment Project conducted through the Detroit Health Department provided quality care to over 300 people with diabetes. Self Management Education classes are conducted regularly; professional staff are encouraged to seek a Certified Diabetes Educator Credential; and collaborated with more than 20 partners in the Detroit area. Enrolled 4,000 persons in the Michigan DON Care Improvement Project.
- Improved the quality of care being provided to persons with diabetes in order to reduce mortality rates, incidence of complications and hospitalizations.

Project Goals for FY 2002:

- Serve over 400 persons with diabetes through the Detroit Empowerment Project.

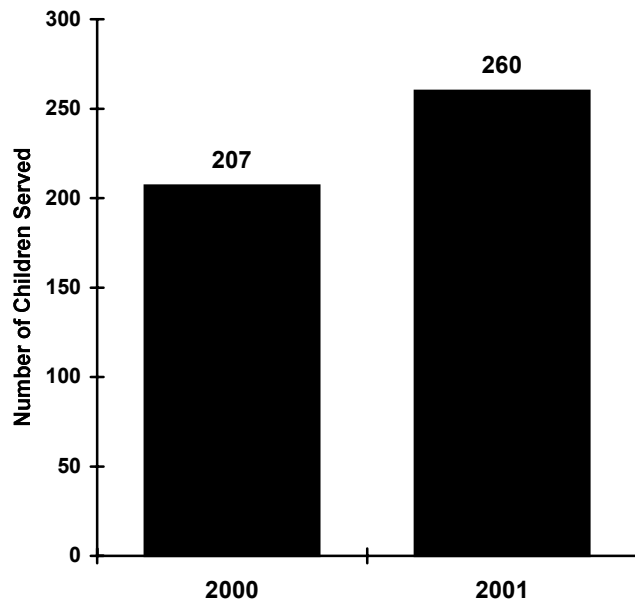

Project Description:

The Outreach Program seeks to establish comprehensive screening of high-risk populations in greater metro Detroit with low utilization of preventive health services and high rates of diabetes and related complications. Community based programs for diabetes control has been established in churches to provide educational and self-management skills for lifestyle changes and diabetes control. Diabetes clinics are conducted in target counties to provide education and treatment to individuals under the age of 21 with type 1 diabetes in underserved areas.

Project Accomplishments for FY 2001:

- Developed a Community Based Diabetes Intervention program to enable people with diabetes to take charge and to provide information for those at risk for diabetes. Over 800 individuals have participated in 60 faith-based programs.
- The outstate Outreach Program saw over 260 children with type 1 diabetes and provided comprehensive medical programs in over 8 sites across the state.
- Organized 4 annual international diabetes symposia addressing diabetes issues.

Project Goals for FY 2002:

- Continue to provide comprehensive care to children having type 1 diabetes who are economically disadvantaged or who live in remote areas of Michigan.

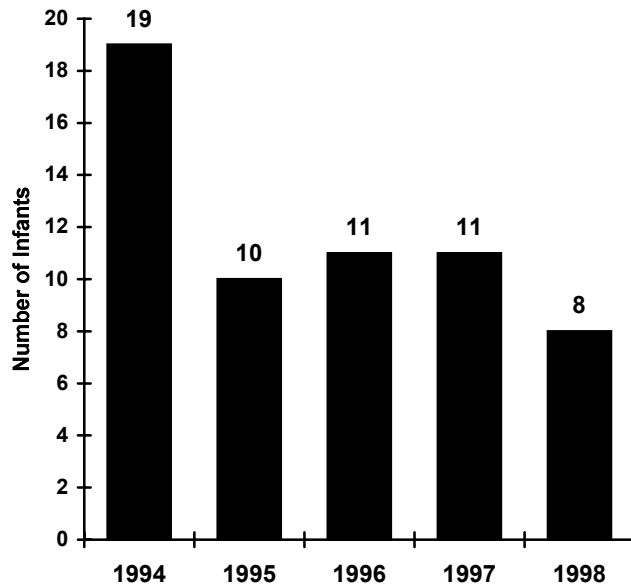

This project is funded for one year.

Project Accomplishments for FY 2001:

- A total of 2,456 HCV EIA tests were performed at the Lansing laboratory. Of these, 88 were confirmed to be HCV positive by PCR. Greater than 85% of the HCV tests performed were from individuals in Southeast Michigan who were also at high risk for HIV infection.
- Referrals to health care providers and support groups were given to the 88 clients who tested HCV positive.
- All clients tested for HCV were provided with risk-reduction counseling and information to avoid future infection.

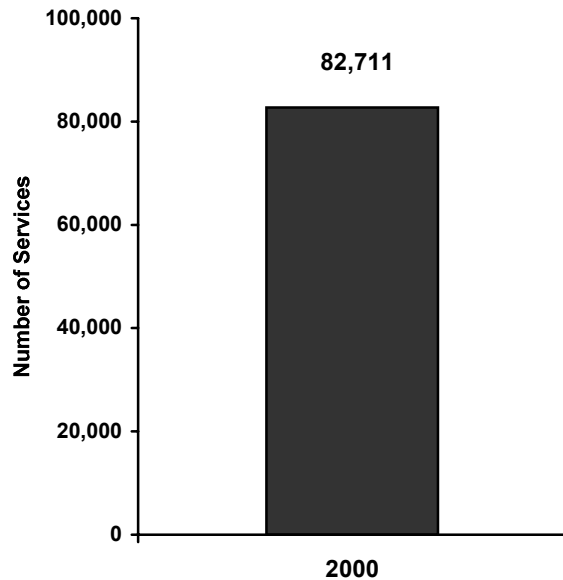

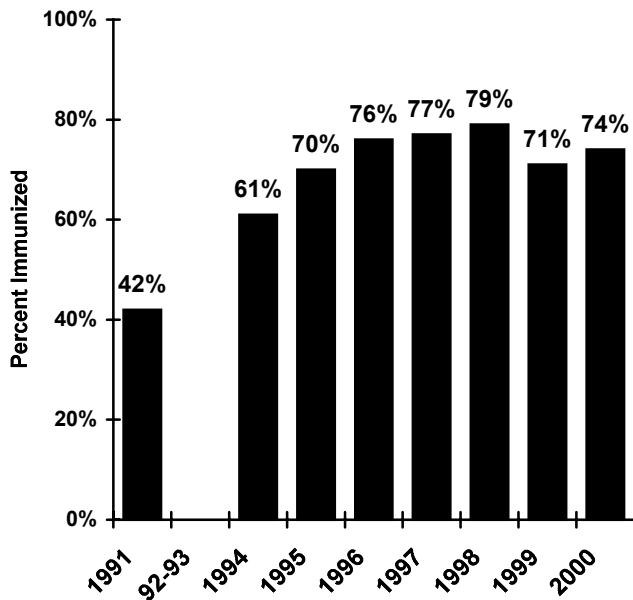

Project Description:
 Michigan Childhood Immunization Registry (MCIR) is a regionally based statewide childhood immunization registry that already contains 22 million shot records of 2.2 million children in the state. The department is currently working through subcontracts with six MCIR regions to enroll every provider of immunizations in the state. Currently there are approximately 2,600 provider sites enrolled, with about 550 daily unique provider log-ins to the registry. Users are able to access a child's record to determine if they need additional vaccines. The MCIR will generate recall cards to notify those responsible parties whose children have missed shots to encourage them to visit their immunization provider and receive the needed vaccine. The regional activities discussed above are funded using the Healthy MI Fund.

Project Accomplishments for FY 2001:

- 79 percent of private provider sites are enrolled in the MCIR.
- 97 percent of the resident children age 0-60 months are registered in the MCIR.
- 2.2 million children under the age of 20 years are registered in the MCIR.
- 100 percent of local health departments submit data to the MCIR at a minimum weekly.
- 51 percent of private providers have submitted immunization data during 2001
- 69 percent of the 19 through 36 - month old children in the MCIR have at least 2 immunization dates added to the MCIR.

Project Goals for FY 2002:

- 95 percent of private immunization providers will access the MCIR at least once a week.
- 80 percent of immunizations will be recorded in the MCIR within seven days of administration.
- 75 percent of all children in the MCIR who do not have complete immunizations will be notified.
- Complete the development of the web-based MCIR system and fully implement it statewide.
- Coordinate activities with Managed Care Organizations to provide MCIR data to supplement their HEDIS reports.

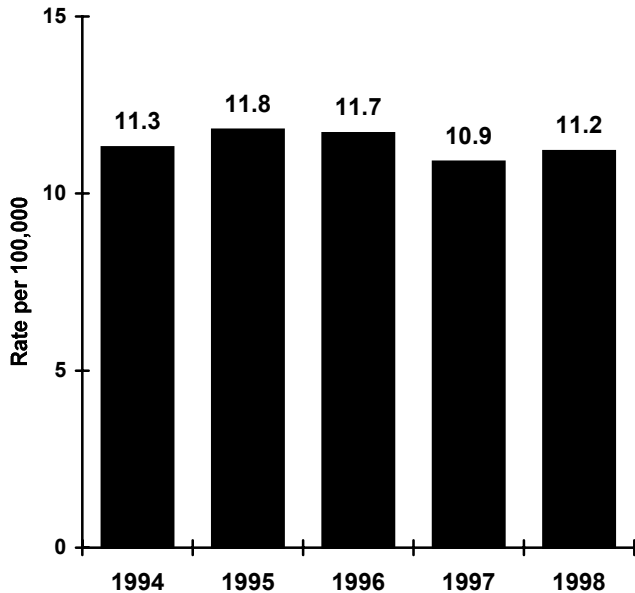

Project Name: Injury Control Intervention Project

Target Population: The Traumatic Brain Injury (TBI) program targets Michigan residents with a TBI and their families. The Michigan Emergency Department Community Injury Information Network (MEDCIIN) program targets Michigan residents who visit an emergency department for an injury.

Project Description:

-TBI Program: This program is responsible for identifying, coordinating and maximizing services available to TBI consumers and their families and for identifying gaps in and recommending changes to service delivery systems. The TBI program will continue with federal funding resources but at a reduced level.

-MEDCIIN: This is a voluntary data collection system using a representative sample of 23 emergency departments (EDs) throughout the state to provide data on the types and causes of injuries, injury severity, and demographic characteristics of people seen in EDs for traumatic injuries. The program will continue with federal resources but at a reduced capacity.

Project Accomplishments for FY 2001:

- A TBI Advisory Council and Management Team were responsible for operationalizing recommendations from the 5-year TBI Plan to address the unmet needs of the target population. TBI educational brochures were developed for consumers, families and professionals. A Resource Guide is being finalized for TBI consumers and their families.
- Collaborated with the MDCH Violence Prevention Section to implement the MEDCIIN system. All 23 hospitals signed letters of participation for the MEDCIIN system to complete the statistical sample. Technical site visits were completed with all hospitals to finalize arrangements for submission of data. Technical assistance and feedback on data quality were provided to hospitals and hospital-specific injury reports were prepared for 15 hospitals reporting a full year of injury data for 1999. An aggregate data report was prepared based on 20 reporting hospitals for 1999.
- Received a three-year Implementation grant from HRSA to implement the recommendations outlined in the Planning Grant.
- Finalized and distributed educational brochures for consumers and families, and for professionals working with TBI consumers.
- Re-configured the Advisory Committee to incorporate cultural diversity as well as the variety of perspectives on brain injury.
- Will shortly finalize and distribute a Resource Guide for consumers, families, and professionals which covers the wide variety of information needed for people with TBI, including housing, insurance, legal issues, and medical care.

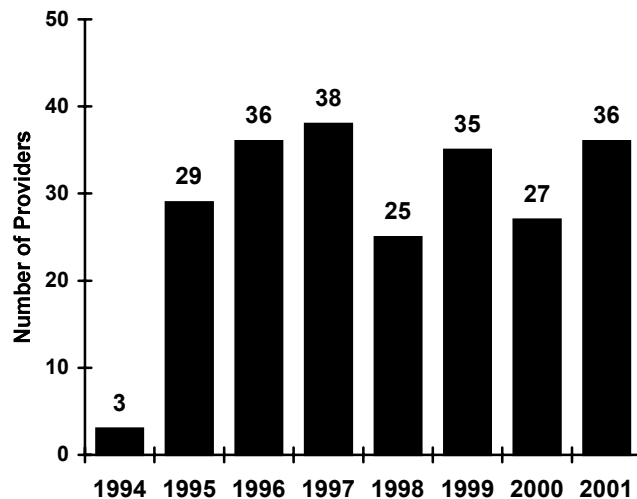

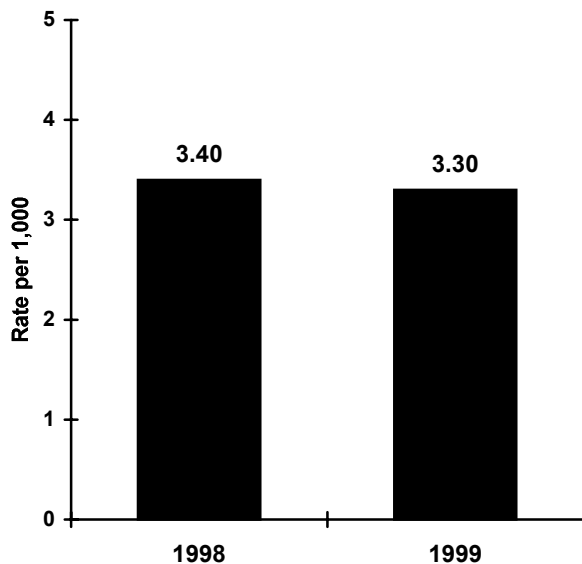

Project Name: Osteoporosis

Target Population:

The Osteoporosis Project addresses the critical health issue of osteoporosis and osteopenia. Osteoporosis and osteopenia affects over 1 million Michigan citizens. The target population is women, children and adolescents, senior citizens, physicians and other health care providers, and the general population.

Project Description:

MDCH funds targeted interventions in fulfillment of the 1999 Michigan Osteoporosis Strategic Plan that include: public and professional education, school health education, community-based screening, development of voluntary quality assurance standards, implementation of an osteoporosis-specific behavioral risk factor survey, community planning for fall prevention, and project evaluation. It is administered through a master contract with MPHI, who in turn, subcontracts with community and statewide partnership agencies.

Project Accomplishments for FY 2001:

- Developed and pilot-tested two physician continuing education modules, Medication-Related Osteoporosis and Prevention and Treatment of Osteoporosis in the Nursing Facility.
- Developed voluntary quality assurance standards for bone densitometry providers.
- Distributed 150 copies of the Mall-Walking Manual and implemented pilot mall-walking projects at three shopping malls. Distributed 250,000 copies of intergenerational Osteoporosis Newsletters.
- Distributed 26,000 adolescent-targeted brochures to pediatricians and family practitioners. Conducted the Osteoporosis/Arthritis Behavioral Risk Factor Survey.
- Implemented community screening, education, referral and follow-up, using four different subcontractors. Trained 104 community educators to implement community education programs.
- Convened a work group to write a fall prevention position paper, fall prevention workshops, research additional funding opportunities and funded a fall prevention planning grant.
- Completed pilot testing and evaluation of the Michigan Model Osteoporosis lessons for grades 2 and 3. A full evaluation report will be available later this fall.

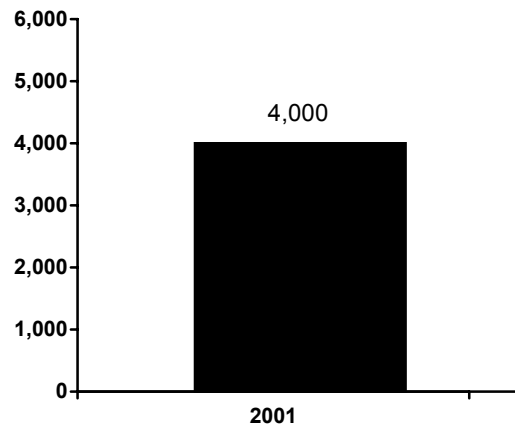

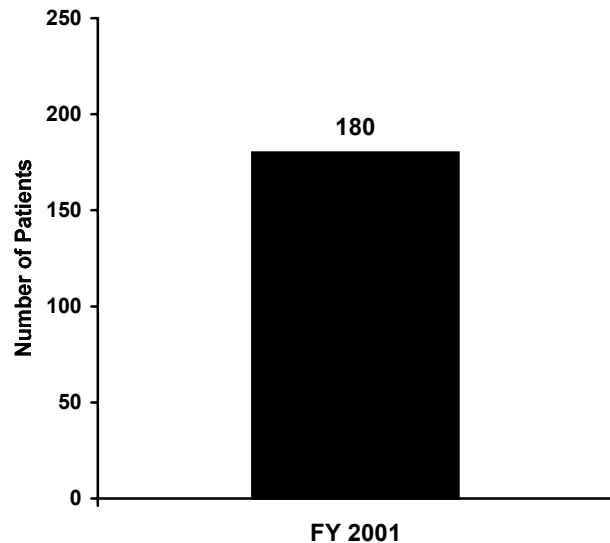

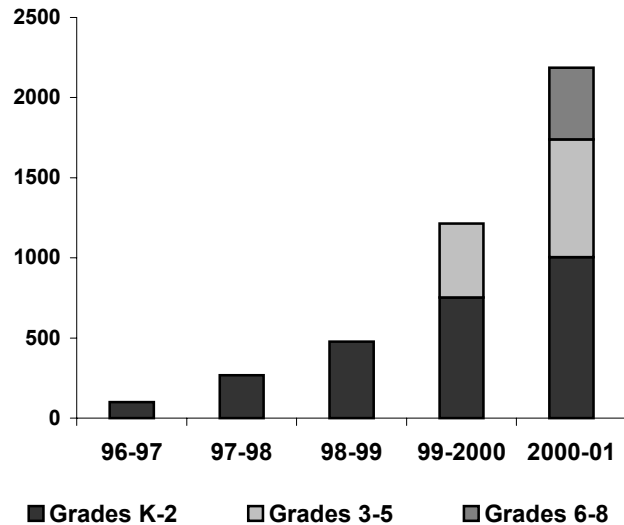

Project Name: Physical Fitness, Nutrition and Health

Target Population: All citizens of Michigan, particularly the 50% of the population classified as sedentary and the 62% that are overweight or obese.

Project Description:

Increase physical activity for 1,000,000 of Michigan’s sedentary citizens within the next 5 years. Projects have been chosen based on recommendations from the Governor’s Council on Physical Fitness. The majority of activities are contracted out to the Michigan Fitness Foundation (MFF).

Project Accomplishments for FY 2001:

- Purchased lessons for Grades K-2 by a total of 1,005 teachers, representing 58% of Michigan’s school districts. Grades 3-5 lessons are being used by 734 teachers (43% of districts). The new Grades 6-8 “Personal Conditioning” lessons were adopted by 448 teachers (33% of districts). The first secondary lessons (Grades 6-12) are being developed.
- Physical activity awareness: 378 print stories appeared in 184 publications; aired 600 television and 288 radio features; posted four online news stories; 66,145 web site hits; shared over 589,000 written educational pieces with Michigan children and families; 377,313 people attended public presentations or health fairs related to physical activity. Distributed sports injury prevention booklets (3,759 football and 9,050 in-line skating) to coaches, parents and young athletes. Hosted 87 physical activity events.
- Eleven Michigan communities underwent a self-assessment process to identify ways citizens could increase physical activity. 750 people attended an awards event that recognized 225 agencies and individuals for helping others increase their physical activity.
- Eleven regional fitness councils brought together 470 local agencies to promote physical activity locally. Nine \$5,000 grants were awarded to local recreation departments, who provided supervised physical activity programs for 6,749 youth at risk for substance abuse and violence. The MFF raised \$613,677 in cash and in-kind contributions to extend physical activity programming.

Project Goals for FY 2002:

- Market physical education curriculum and train more teachers in its use, with the goal of over 1100 teachers at Grades K-2, 750 at Grades 3-5, 550 for the Grades 6-8 “Personal Conditioning” lessons. Produce a secondary school course and train at least 150 teachers in those lessons. Market the curriculum nationally to offset the cost to Michigan schools.
- Increase opportunities for physical activity by encouraging at least 15 communities to conduct self-assessments. Increase awareness of health benefits of physical activity by organizing over 300,000 Michigan children to participate in the All Children Exercising Simultaneously event; publicly recognize at least 200 awardees who are helping others be physically active; publish a position paper on injury prevention in three sports; public presentations, workshops, and media kits. The MFF will raise at least \$500,000 to extend physical activity programming.

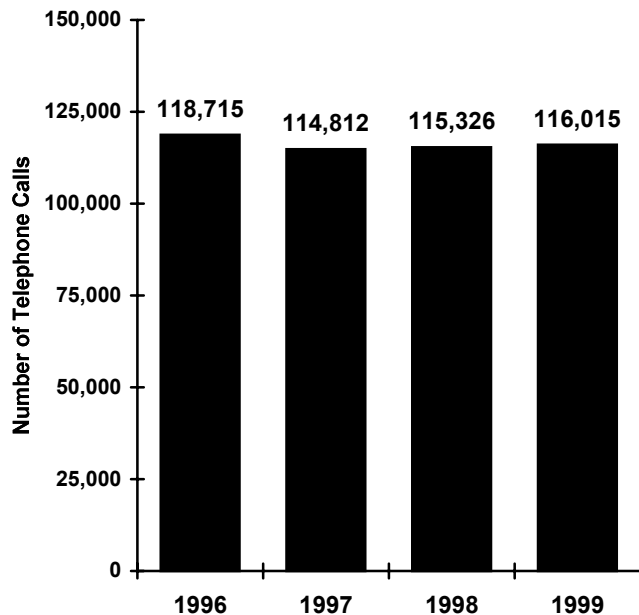

Project Name: Poison Control

Target Population:

All Michigan residents.

Project Description:

The Michigan Poison Control System consists of two regional certified poison centers: Children's Hospital of Michigan Regional Poison Control Center (CHM) in Detroit and Spectrum Health, and the DeVos Poison Control Center in Grand Rapids. The centers provide 24 hour-per-day, 365 days -per-year, toll free telephone access for poison triage and first aid advice. The Poison Control program utilizes a comprehensive approach to preventing poison exposures through education of the public and to minimize severity of injury by education of health care professionals in the latest treatment for poison. The two centers receive a total of \$695,000 from the state of Michigan divided according to the populations that they serve. Detroit receives \$438,545 while Grand Rapids receives \$256,455.

Project Accomplishments for FY 2001:

- Telephone triage to public (information and advice).
- Consultative service to health care providers.
- Provided consultations by medical toxicologists.
- Provided public education through health fairs, community presentations, publications and other venues.

Project Goals for FY 2002:

- Utilize and promote new nationwide telephone number within our geographical service area.
- Implement T1 line to provide database integration with the DeVos Children's Poison Center.
- Continue existing public and health professional educational activities.
- Provide the services to Michigan's population maintaining the same level.

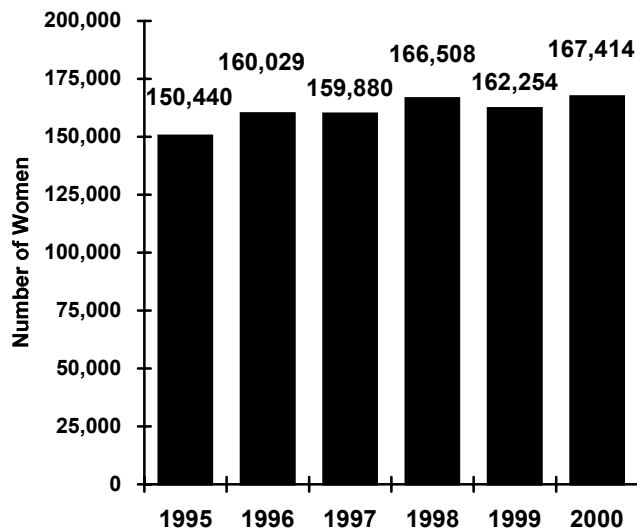

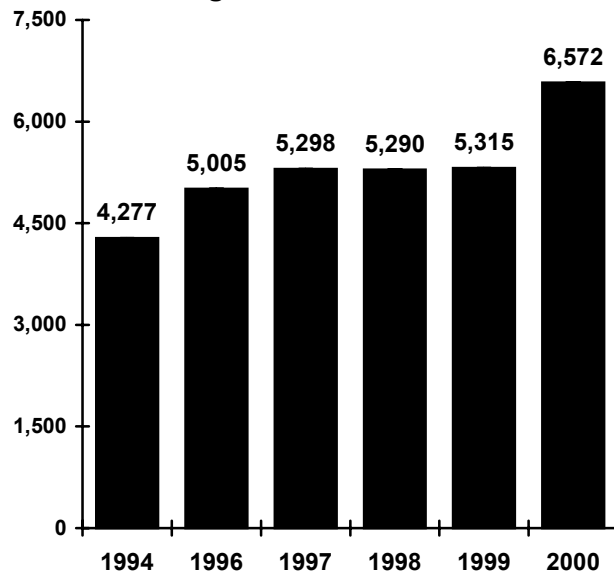

Project Name: Prenatal Care

Target Population:

High-risk pregnant, low-income Medicaid eligible women and their infants.

Project Description:

The Maternal and Infant Health Advocacy Services (MIHAS) Program is designed to outreach to pregnant women who are not in prenatal care, assist high-risk women in dealing with situations that may keep them from remaining in prenatal care, and support and reinforce the health education messages delivered by professionals. MIHAS activities are delivered by health paraprofessional advocates, specifically trained to deal with psychosocial problems of high-risk, low-income, pregnant women. The first priority for selection of advocates is that they are indigenous to the community.

Project Accomplishments for FY 2001:

- Provided two trainings to program staff on client motivation.
- Collaborated with local service providers to develop MIHAS client screening tool.

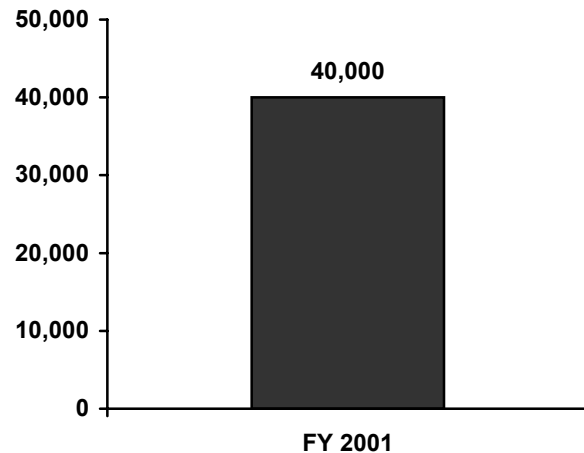

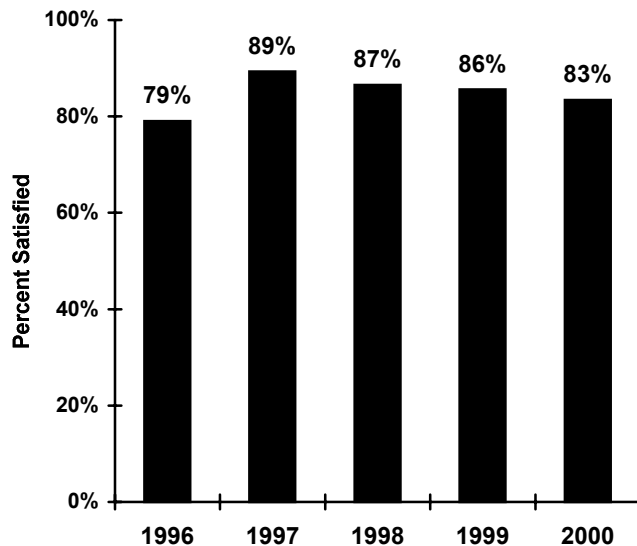

Target Population:

Respite Care for Children with a Serious Emotional Disturbance (SED)

Project Description:

Respite care services are provided to children with SED and their families. Respite care programs are administered through Community Mental Health Service Programs throughout Michigan. Respite care provides relief to children with SED and their families, thus reducing out-of-home placement, crisis intervention or inpatient psychiatric services. This valuable resource allows families to receive community-based services and assists in overall family functioning.

Project Accomplishments for FY 2001:

- More than 4,000 children with SED and their families received respite care services.

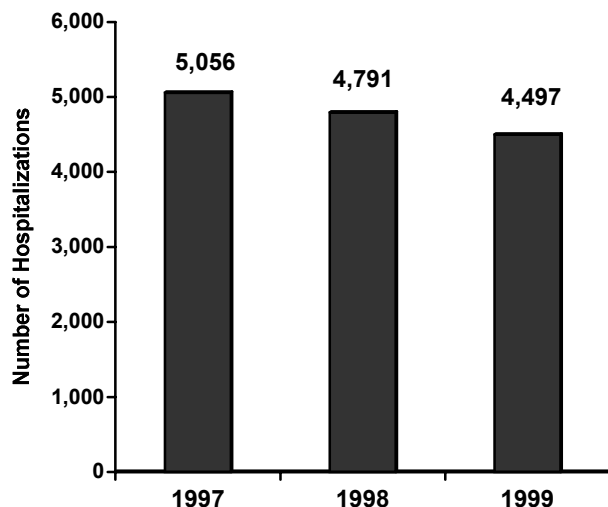

Project Name: Safe Kids Program

Target Population: Childhood injury prevention initiatives target children and youth, parents and other caregivers, and professionals responsible for promoting community-based injury prevention.

Project Description

The goal of this program is to strengthen and expand the SAFE KIDS Coalition network and infrastructure in Michigan through regional coordination and community-based prevention activities. Three Regional SAFE KIDS Coordinators are responsible for assisting local SAFE KIDS Coalitions/Chapters within the region to implement and evaluate coordinated, multi-faceted, comprehensive local programs to prevent childhood injuries.

Project Accomplishments for FY 2001:

- Continued three regional coordination sites. Formed five new chapters in areas where none previously existed.
- Awarded community partnership grants to 34 SAFE KIDS Chapters/Coalitions to implement and evaluate coordinated, multi-faceted, comprehensive local programs to prevent childhood injuries related to child passenger safety, bicycle/pedestrian safety, water safety, fire safety, sports injury prevention, equestrian safety, emergency services training (911), poison prevention, agricultural safety and firearm safety.

- Implement regional activities to strengthen existing coalitions/chapters, establish new coalitions/chapters, and promote childhood injury prevention through highly visible public education initiatives.

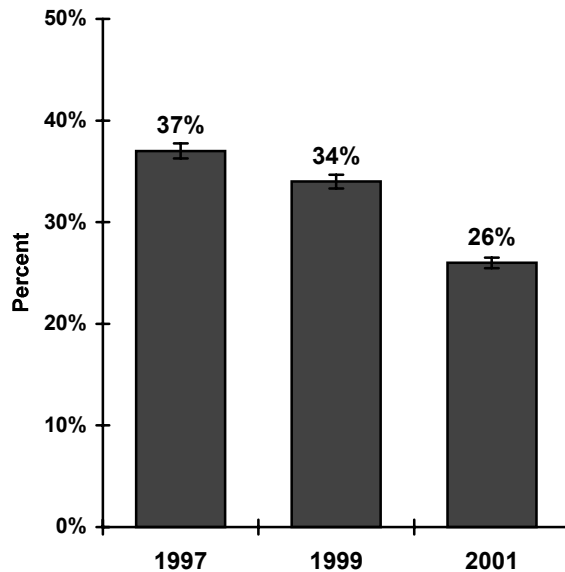

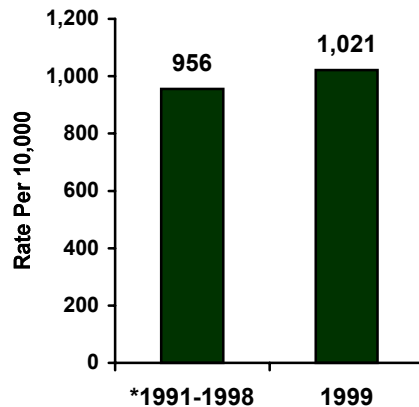

Project Name: Senior Nutrition Services

Target Population:

Homebound senior citizens age 60 and over.

Project Description:

Home-Delivered meals are served to persons who are age 60 or older, homebound, and have no other meals of meal preparation. Meals served must meet nutritional requirements that specify 1/3 of RDA (Recommended Dietary Allowance) be low in sugar, fat, and salt. Meals are to be available at least five days a week. This funding enables the provision of meals for weekends and holidays and special diet meals as appropriate.

Project Accomplishments for FY 2001:

- Provided over 236,900 meals to over 1600 homebound seniors.
- Funds utilized for Home Delivered Meals include 35.1 percent federal funds, 35.2 percent state funds, and over 29.2 percent are local funds including senior contributions.
- Over 40% of the funding for meals goes toward the purchase of the food; the balance is used for labor, administration, equipment delivery and supplies.
- Home Delivered Meals participants contribute an average of \$0.67 per meal or an additional \$158,700 toward the cost of these meals.
- USDA funds contribute an additional \$127,926 toward the cost of these meals.

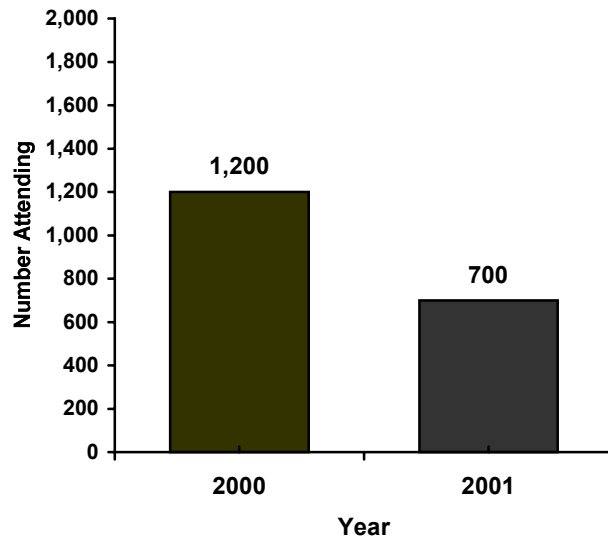

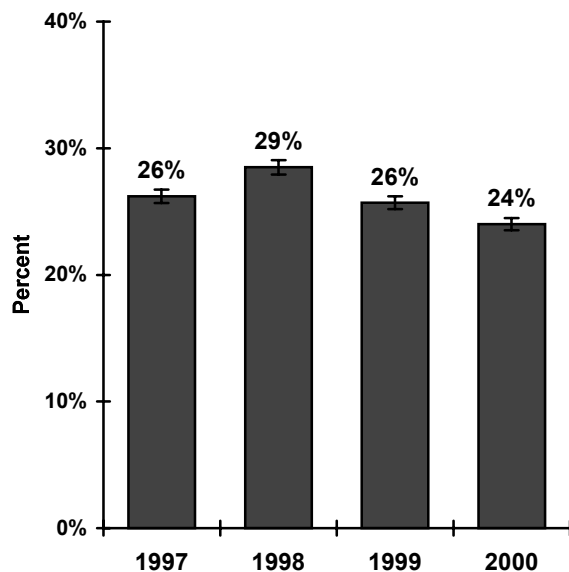

Target Population:

Project Description:

Prevent children from initiating tobacco use, encourage and assist tobacco users in quitting, educate the public on the dangers of secondhand smoke, promote smoke-free environments, and increase awareness about the impact of tobacco on minority populations. Funds are dispersed via community and statewide contracts.

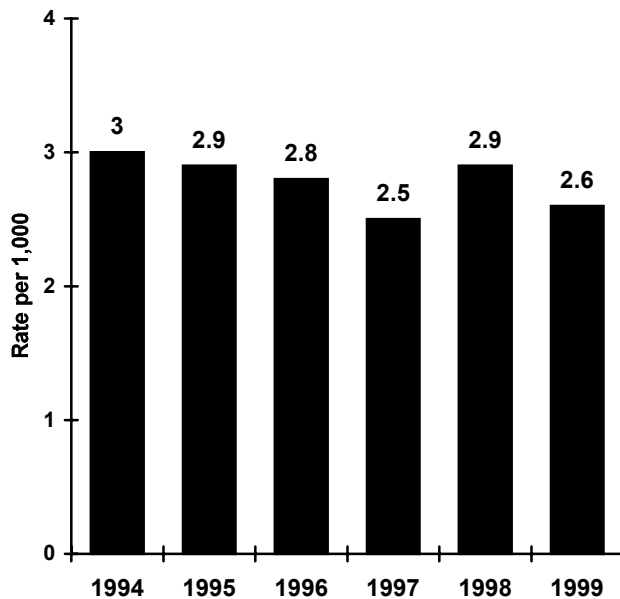

Project Name: Sudden Infant Death Syndrome (SIDS)

Target Population:

Expectant and parenting families in Michigan.

Project Description:

The Michigan Sudden Infant Death Services Program provides risk reduction, family support and surveillance services. Risk reduction focuses on a national campaign entitled “Back to Sleep” which educates families on safe sleep position for infants, through media and literature. The program provides coordination of professional and peer support to those affected by the experience of sudden infant death. Reimbursement for home visits is available for local health department providers through their contract with the Department of Community Health. Surveillance for sudden infant death involves reimbursement for autopsies on sudden infant death, which include death scene investigation, medical history and autopsy findings. The program will continue with federal maternal and child health block grant funding resources.

Project Accomplishments for FY 2001:

- Developed a referral database for bereavement services.
- Conducted training for revised peer contact system to include non-SIDS deaths.
- Held a statewide Professional Training May 10 -11.
- Revised the Professional Services Manual.
- Offered 8-10 monthly trainings to various audiences targeted at daycare providers.
- Developed infant safe sleep brochure, poster, and display.
- City of Detroit Health Department staff visits Medicaid providers in high-risk zip codes to distribute Back to Sleep materials.
- Continued collaboration with Healthy Start, Fetal and Infant Mortality Review and Child Death Review on both local and state level.
- Introduced discharge summary form to be used by target counties. A discharge summary relates to closing a bereavement case so that uniform data is collected on a single form (i.e., discharge from home visiting service).

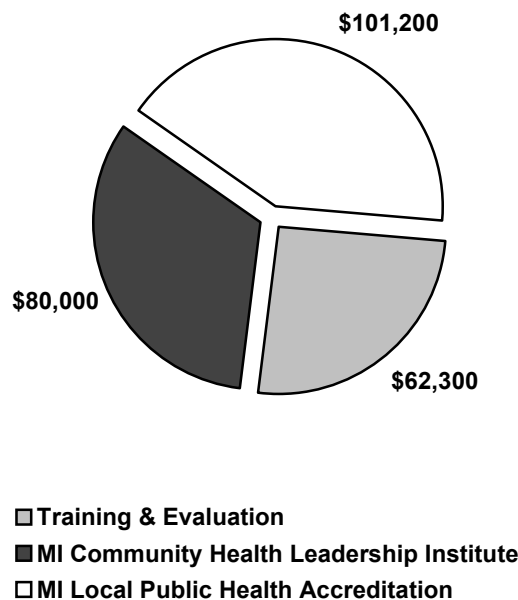

Project Name: Training and Evaluation

Target Population:

45 Local Public Health Departments serving 83 Michigan Counties.

Project Description:

Training and Evaluation: MDCH administers funds appropriated through the Public Health Code (P.A. 368 of 1978) for the development and implementation of training events for local health department staff in the delivery of required and allowable public health services. Leadership Institute: This collaborative effort by MDCH, academic institutions, private sector, and non-profit partners provides a year long program for selected scholars to build leadership skills. Local Public Health Accreditation: This program provides an accreditation process for 45 local public health departments and seeks to assure and enhance the quality of local public health in Michigan through the identification and promotion of public health standards.

Project Accomplishments for FY 2001:

- Training and Evaluation: Training activities conducted in areas related to personal, environmental, and behavioral health issues; approximately 1,400 individuals participated in these areas of public health related training.
- Leadership Institute: Twenty-six mid and upper level professionals in local, regional, state, public, and private settings enhanced their leadership capabilities and skills through completion of this advanced educational program.
- Michigan Local Public Health Accreditation: Completed 16 on-site reviews at local health departments, thereby completing the first three-year cycle of local health department performance review. Additionally, the accreditation tool was revised to reflect annual changes in minimum program requirements.

Project Goals for FY 2002:

- Training and Evaluation: To increase competency and capacity related to the delivery of required health services under Michigan's public health code through continued and new training of over 1,000 targeted staff.
- Leadership Institute: To strengthen public health competency through the advanced leadership training and skill building of 28 local, private, and state public health professionals.
- Michigan Local Public Health Accreditation: To begin the second three-year cycle of local health department performance evaluation by conducting on-site reviews at 9 local health departments.

Target Population:

Project Description:

The Violence Prevention Section is charged with implementing the recommendations in the report Safe Michigan. The major section components are: (1) managing and providing technical assistance/consultation for funded grants to local communities for coalition support, strategic planning and implementation around a violence issue important to the community; (2) managing federal funds for rape and sexual violence prevention, program evaluation, and surveillance; (3) implementing and evaluating an intimate partner violence surveillance; and (4) community violence prevention assessment, evaluation, and data collection efforts.

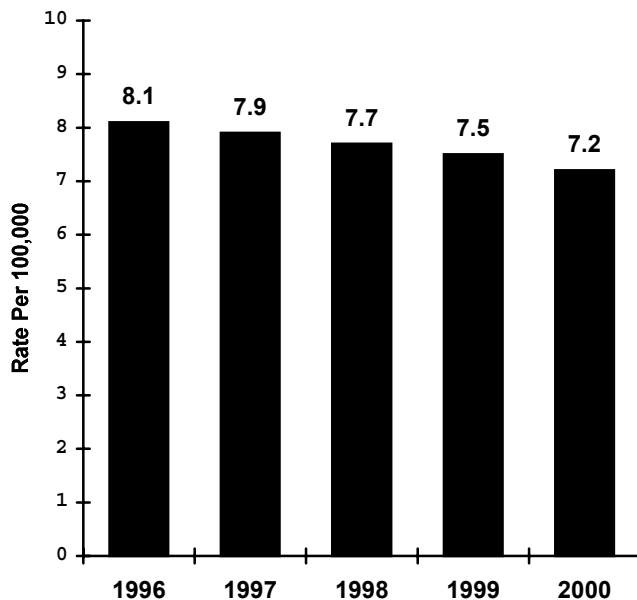
Project Accomplishments for FY 2001:

- Managed eighteen grants to local agencies to support community, youth, and violence against women prevention planning, coordination, and intervention; and twenty grants to local agencies for sexual assault prevention programs.
- Contracted with the Neighborhood Partnership in Detroit to support violence prevention and reduction activities through work with the faith community.
- Funded eight comprehensive, three-day community assessments to assist communities in evaluating their youth violence prevention status and examining how they can improve their efforts. Expanded the web-based Community Assessment Tool, organizations in looking at violence and related issues in their communities.
- Enhanced a nationally recognized model surveillance programs for intimate partner violence and sexual assault. The Michigan Emergency Department Community Injury Information Network (MEDCIIN) completed its first year of data collection and analysis. Over 162,000 cases are now in the system.
- Provided ongoing technical assistance to 45 sexual assault prevention and service delivery programs. Received support for a campaign on domestic violence.
- Continued the Michigan Medical Examiners Uniform Reporting System.

Project Goals for FY 2002:

- Continue working with community groups to prevent and reduce morbidity and mortality related to violence in homes, schools and streets. This program will end as of December 31, 2001.
