## Mental Health and Substance Abuse Reporting Requirements Section 425 of Public Act 60 of 2001

The FY 2002 Appropriation Act, Section 425, requires that the Department of Community Health report information by March 1, 2002 on both substance abuse and mental health programs provided to prisoners.

Following is the text of Section 425 and the three subsections of the boilerplate followed in each case by the Department's responses (in italics):

By March 1, 2002, the Department, in conjunction with the Department of Corrections, shall report the following data from Fiscal Year 2000-2001 on mental health and substance abuse services to the House of Representatives and Senate Appropriations Subcommittees on Community Health and Corrections, the House and Senate Fiscal Agencies and the State Budget Office:

Subsection (a) The number of prisoners receiving substance abuse services which shall include a description and breakdown on the type of substance abuse services provided to prisoners.

The information provided in Subsection (a) below was supplied by the Department of Corrections from their boilerplate report. The Department of Corrections is responsible for providing substance abuse services to prisoners.

Outpatient Substance Abuse Services (group and individual counseling provided in 37 prisons - all but maximum security - and twelve camps). Total admissions for assessment and treatment - 6,379.

Residential Substance Abuse Services (group and individual counseling and other rehabilitative efforts provided in controlled environments for prisoners unable to be treated successfully through outpatient services). Total admissions for assessment and treatment - 1,200.

Substance Abuse Education Services (educational and motivational information provided to prisoners with substance abuse problems in 41 prisons). Total number of enrollees - 5,121.

Subsection (b) The number of prisoners receiving mental health services which shall include a description and breakdown on the type of mental health services provided to prisoners.

Acute Inpatient Care (inpatient hospital services provided at Huron Valley Center and for part of the year at Duane Waters Hospital Unit) Average annual census – 81.0

Subacute Care (inpatient care provided in a hospital setting at Huron Valley Center). Average annual census – 174.0

Crisis Stabilization Services (provided in small units in non-hospital settings at Riverside Correctional Facility and, for part of the year, at the Duane Waters Hospital in Jackson). Average annual census – 4.0

Residential Treatment Programs (specialized mental health programs provided in prison settings at Riverside Correctional Facility, Huron Valley Correctional Facility, Gus Harrison Facility/Adrian, Scott Correctional Facility). Average annual census – 601.0

Outpatient Mental Health Services (mental health services provided in general population settings by clinical teams at 13 prison locations across Michigan). Average annual caseload (all teams) - 1902

Subsection (c) Data indicating if prisoners receiving mental health services were previously hospitalized in a State psychiatric hospital for persons with mental illness.

A total of 664 prisoners currently receiving mental health services were previously hospitalized in a State psychiatric hospital (as of February 20, 2002). To put this number in context, there were (as of February 20, 2002) 2,930 prisoners in treatment and approximately 50,000 prisoners in the system.
