**Proposed 100-word Summary of Purpose as Drafted by the Director of Elections**

An initiation of legislation to amend the Michigan Election Law, 1954 PA 116, MCL 168.495, 523, 759, 759a, 759b, 761, 761b, 764b, 813, and add 168.523b, 760a, 946, to: require a partial social security number for voter registration; require photo ID to vote and eliminate affidavit for voters without ID; require a driver's license, state-ID, or partial social security number, or photo ID, to vote absentee; require voters without ID to cast provisional ballot and show ID within 6 days after election; provide state-funded IDs to applicants with hardships; specify times when clerks must accept absentee ballot delivery; prohibit officials from making absentee ballot applications available except upon voter request; prohibit donations to fund elections.
