Dave Massaron, Chief Operating Officer, gave a brief overview of the resolution, noting that the City of Detroit is requesting an FRC advisory vote to support its efforts to amend the City's bankruptcy Plan of Adjustment (POA) to lengthen the amount of time members of the Detroit Police Lieutenants and Sergeants Association (DPLSA) and the Detroit Police Command Officers Association (DPCOA) may work under the City's Deferred Retirement Option (DROP). He stated that the proposed change to the DROP program would effectively be cost-neutral, and it would greatly assist the City's efforts to retain experienced, well-trained officers.

Motion made to approve the City's advisory vote request (City Resolution 2018-14) as presented. Motion moved and supported. The Commission approved City Resolution 2018-14 as presented.
